

Supergravity in twelve dimension

ABSTRACT: We consider supergravity in twelve dimension, whose dimensional reduction yields eleven-dimensional, IIA, and IIB supergravities. This also provides the effective field theory of F-theory. We must take one direction as a compact circle, so that the Poincaré symmetry and the zero-mode field contents are identical to those of eleven-dimensional supergravity. We also have a tower of massive Kaluza-Klein states to be viewed as the wrapping modes of M2-branes. The twelfth dimension decompactifies only if other two directions are compactified on a torus, restoring different ten dimensional Poincaré symmetry of IIB supergravity, whose missing graviton is provided by components of the rank three tensor field. This condition prevents us from violating the condition on the maximal number of real supercharges, which should be thirty-two. The self-duality condition of the IIB four-form fields is understood from twelve-dimensional Hodge duality. In this framework T -duality is re-interpreted as taking different compactification routes.

1 Introduction

This paper tries to tie up the loose ends of what have been known separately about duality relations of superstrings and supergravities. We are particularly interested in the completion of IIB supergravity [1]; First we consider a possibility to embed it into a certain higher dimensional supergravity. This turns out to require twelve dimension in total, in which the existence of supergravity is challenging. Also we want to concretely elucidate its T -duality to IIA supergravity. Although T -duality relation between type IIA and IIB

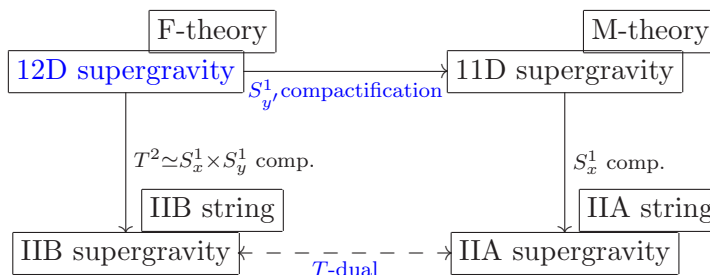


Figure 1. Relation among superstring and supergravity theories. The IIB theory can be interpreted to be obtained by compactifying the twelve-dimensional theory on torus. This T -duality holds between the two string theories if we remove the common directions.

supergravities compactified on circles is known [2–9], we do not know which physics gives rise to such rules.

The formulation of superstring theories led us to discovery of a number of ten dimensional supergravity theories as the corresponding effective field theories. It has been soon realized that, between two possible supergravity theories of thirty-two supercharges, type IIA supergravity action can be obtained by dimensional reduction of an eleven-dimensional one, which is unique [10]. The latter has less number of multiplet fields and simpler form of interactions, at the price of introducing an extra dimension. Dimensional reduction from a simpler, if not more fundamental, theory has become a central paradigm, and many features of realistic models are understood as geometric properties of extra dimensions [11, 12]. For example, four-dimensional models describing our world are hoped to be obtained from a higher dimensional supergravity in a simpler form [13–20]. A natural question now is whether we can also obtain the other supergravity of type IIB by dimensional reduction of a higher dimensional theory.

It is well-known now that type IIB superstring theory is more deeply understood as a dimensionally reduced one from F-theory with two more dimensions, for the following reasons [21]. In the Einstein frame where the graviton kinetic term is canonical, the effective theory of IIB supergravity action entertains $SL(2, \mathbb{R})$ symmetry, and kinetic terms for scalar fields take forms of those of moduli fields of two extra dimensions. By string quantization the duality group reduces to $SL(2, \mathbb{Z})$, which coincides with the symmetry of a torus [24]. It is F-theory that identifies these two symmetries; the complexified field τ of axion and dilaton is identified as the complex structure of the torus, which depends on ten-dimensional spacetime [21, 22]. Now the problem is translated to find such twelve-dimensional theory fully. Compactification of this twelve-dimensional theory requires understanding on the graviton components in the internal dimensions.

Any attempt to construct twelve-dimensional supergravity with full Poincaré symmetry immediately faces obstacles. First, there is a classification on possible supermultiplets [25]. The maximal number of real supercharges, or supersymmetry generators, is thirty-two. In four dimensions, this brings the helicity-(-2) state of a graviton to a helicity-2 state, resulting in superpartner fields of gravitino and set of vector, scalar, spinorial fields. This set

of supersymmetry generators and multiplets are best understood as dimensional reduction of simpler generators in higher dimensions. The maximal number of spacetime dimensions with one opposite Lorentz signature for the time allowing this spinorial representation is eleven. Indeed, compactification of eleven dimensional supergravity theory on a circle gives ten-dimensional IIA supergravity with a $(1, 1)$ supersymmetry [10]. The other ten-dimensional supergravity, IIB, has a $(2, 0)$ supersymmetry. We cannot have supergravity with more supersymmetry generators since otherwise we must have a field with spin higher than two in four dimensions. No consistent interacting theory with spin higher two is known possible. This is the reason why we cannot have twelve-dimensional supergravity with the full Poincaré symmetry. Noting that the Clifford algebra with Lorentz signature $(1, 9)$ is isomorphic to that with $(2, 10)$, one may try to construct thirty-two component spinor in the twelve dimension with two timelike directions [26, 27]. However this is not what we want but we need $(1, 11)$, because the two extra dimensions of IIB theory should be compact thus space-like.

Then, what would be the form of twelve-dimensional supergravity, if there should exist a effective field theory of F-theory? The derivation of F-theory from M-theory hints us the meaning of the twelfth dimension [21, 28, 29]. It is well-known that eleven dimensional supergravity is a field theory limit of M-theory [30, 31]. F-theory compactified on a torus $T^2 \simeq S_x^1 \times S_y^1$ is dual to M-theory compactified on the *same* torus in the zero size limit, thus we may expect the same relation also in the effective field theory limit. Lower dimensional effective actions than twelve have been studied in this context [32–39].

To be more detailed, T -duality takes one of the torus cycle in the M-theory side, say S_y^1 , to another dual circle $S_{y'}^1$ in the F-theory side. Since the radii of these circles are inversely related $R_y = \ell_s^2/R_{y'}$ in the string length unit ℓ_s , in the zero size limit $R_y \rightarrow 0$ of one circle, the other circle $S_{y'}^1$ becomes decompactified, restoring different Lorentz symmetry in *another* ten dimension. Although we cannot maintain twelve-dimensional Lorentz symmetry fully, each ten- and eleven-dimensional theories are consistent in its *own* space. Still, however, F-theory possesses the torus, on which it is compactified to yield type IIB superstring. In other words, the torus T^2 is shared by both theories.

Therefore, although these two circles S_y and $S_{y'}$ are redundant, it is natural to keep *both circle directions* together [1]. Remarkably it turns out that there is no contradiction in the sense that we cannot see the twelve dimensions fully but only part of dimensions that we have known, and this ‘closing dimensions’ shall be automatically taken into account by moduli fields. In this framework, M-theory looks like a dimensional reduction of F-theory in the decompactifying torus limit, as schematically shown in figure 1. Following the program, we have presented the bosonic action in ref. [1], which is discussed in more detail in sections 2 and 3. Another nontriviality comes from the fate of the fields of IIB supergravity and their interactions. There have been many attempts to suggest possible terms in various contexts [41–43]. In this paper, we complete the supergravity action up to linear order of fermions in section 4.

Sometimes we underline the curved coordinate when we need to distinguish.

Warning: To ‘derive’ type IIB supergravity starting from a suggested twelve-dimensional action, we first work in the Einstein frame before section 4, which enables us to ‘discover’ string as one dimensional tensionful object. From section 4, however, it is convenient to work in the string frame, whose details are given in the appendix.

2 The twelve-dimensional bosonic action

First we describe the bosonic part of twelve-dimensional supergravity. We should have one dimension compactified on a circle, so that at best we have eleven-dimensional Poincaré symmetry. We will see that the *massless* degrees of freedom matches to those of eleven-dimensional supergravity.

2.1 Twelve-dimensional action

The bosonic degrees of freedom of eleven-dimensional supergravity are a graviton G_{mn} and a rank-three antisymmetric tensor field C_{mnp} . We lift eleven dimensional supergravity action to twelve-dimensional one. The three-form field is promoted to a four-form field as

$$C_{mnp}(x^m) \rightarrow C_{mnp y'}(x^m, y'). \tag{2.1}$$

having the dependence on the twelfth dimension, which we will call y' hereafter. Also the graviton G_{mn} is regarded as a part of the twelve-dimensional graviton. These can naturally appear if we have an orthogonal extra dimension with a metric

$$ds^2 = \mathcal{G}_{MN} dx^M dx^N = G_{mn} dx^m dx^n + r^2 dy'^2, \tag{2.2}$$

where M, N are twelve-dimensional, and m, n are eleven-dimensional indices. Later we will come back to the issue of the off-diagonal component along $dx^m dy'$.

We first suggest an action

$$2\kappa_{12}^2 S = \int d^{11}x dy' \sqrt{-\mathcal{G}} \left(\mathcal{R} - \frac{1}{2} |\mathcal{G}_5|^2 \right) + \frac{1}{6} \int \mathcal{C}_4 \wedge G_4 \wedge G_4, \tag{2.3}$$

and perform dimensional reductions shortly to consistently match known theories. Here, \mathcal{R} is the twelve-dimensional Ricci scalar made of the metric \mathcal{G}_{MN} in (2.2) and \mathcal{G} is its determinant. The forms are defined as follows

$$\begin{aligned} \mathcal{C}_4 &\equiv C_3 \wedge r dy' \\ &= \frac{1}{3!} r C_{mnp} dx^m \wedge dx^n \wedge dx^p \wedge dy' \end{aligned} \tag{2.4}$$

$$\begin{aligned} &\equiv \frac{1}{4!} C_{MNPQ} dx^M \wedge dx^N \wedge dx^P \wedge dx^Q|_{y'}, \\ \mathcal{G}_5 &\equiv G_4 \wedge r dy' \equiv dC_3 \wedge r dy' = dC_4 + C_3 \wedge dr \wedge dy'. \end{aligned} \tag{2.5}$$

Here the third line means we fix one of the component to be y' , for which we have four ways to do it. In particular, the definition in the first line of (2.4), written componentwise

$$C_{mnp}(x^m)r(x^m, y') = C_{mnp y'}(x^m, y'), \quad (2.6)$$

suggests that C_3 is a native eleven-dimensional field, which is related to the twelve-dimensional C_4 through the dependence on y' in r . There have been attempts to treating them independent, which would violate the multiplet condition for the eleven-dimensional supergravity.

The norm and the wedge product are defined as

$$|G_p|^2 = \frac{1}{p!} \mathcal{G}^{M_1 N_1} \mathcal{G}^{M_2 N_2} \dots \mathcal{G}^{M_p N_p} G_{M_1 M_2 \dots M_p} G_{N_1 N_2 \dots N_p}, \quad (2.7)$$

$$\mathcal{C}_4 \wedge G_4 \wedge G_4 = \frac{1}{3!4!4!} \epsilon_{mnp y' m_5 m_6 \dots m_{12}} \mathcal{C}_{mnp y'} G_{m_5 \dots m_8} G_{m_9 \dots m_{12}} dx^m dx^n \dots dx^{m_{12}}. \quad (2.8)$$

Here $\epsilon_{m_1 \dots m_{12}}$ is the totally antisymmetric Levi-Civita symbol. Note that \mathcal{G}_5 is not the exterior derivative of \mathcal{C}_4 , which is usually the case in dimensionally reduced theories. We will define κ_{12} soon. It is important to note that the indices assume only eleven-dimensional coordinates and we have incomplete components for \mathcal{C}_4 . Therefore the action (2.3) has at best *eleven*-dimensional Poincaré symmetry. Nevertheless this form is useful, since we may recover ten-dimensional symmetry in which we *include* the y' -direction.

Finally, there is an extra term from one-loop contribution

$$S_{\text{one}} = -\frac{2\pi \ell^7}{2\kappa_{12}^2} \int \mathcal{C}_4 \wedge I_8, \quad (2.9)$$

where I_8 is a polynomial only dependent on Ricci tensors, which can be found in [44]

$$I_8 = \frac{1}{(2\pi)^4} \left(-\frac{1}{768} (\text{tr} R^2)^2 + \frac{1}{192} \text{tr} R^4 \right).$$

The third term in (2.3), of a Chern-Simons type, has a property

$$12\kappa_{12}^2 S_{\text{CS}} = \int \mathcal{C}_4 \wedge G_4 \wedge G_4 = \int C_3 \wedge r dy' \wedge G_4 \wedge G_4 = - \int \mathcal{G}_5 \wedge C_3 \wedge G_4, \quad (2.10)$$

which looks like integration by parts in the end, although what we actually did is to just follow the definition (2.5) and changed the order of the wedge products. With this, varying C_3 , we obtain the equation of motion for \mathcal{C}_4

$$d*\mathcal{G}_5 = -\frac{1}{2} d(C_3 \wedge G_4) = -\frac{1}{2} G_4 \wedge G_4, \quad (2.11)$$

supplemented by the Bianchi identity

$$d\mathcal{G}_5 = G_4 \wedge dr \wedge dy'.$$

This will not affect the Bianchi identity of G_4

$$dG_4 = d^2 C_3 = 0,$$

which directly follows from the definition.

Exchanging the role of the two, we also have a dual field strength G_7

$$G_7 \equiv *G_5 \equiv dC_6 - \frac{1}{2}C_3 \wedge G_4, \quad (2.12)$$

which defines a six-form C_6 . Componentwise, we have

$$G_{m_1 \dots m_7} = \frac{1}{4!} \sqrt{-\mathcal{G}} \epsilon_{m_1 \dots m_{11} y'} \mathcal{G}^{m_8 n_8} \dots \mathcal{G}^{m_{11} n_{11}} \mathcal{G}^{y' y'} \mathcal{G}_{n_8 n_9 n_{10} n_{11} y'}, \quad (2.13)$$

where the indices are contracted by twelve-dimensional metric (3.2). Since the totally antisymmetric tensor in twelve-dimension has to take one index on y' , C_6 cannot have an index on y' .¹ Although similar Hodge dual operation is possible in eleven-dimensional theory as well, this constraint is unique if we embed it in twelve dimension.

2.2 Reduction to eleven-dimension

We compactfy the extra dimension by identifying the coordinate

$$y' \sim y' + 2\pi\ell, \quad (2.14)$$

where ℓ is a length unit. Nevertheless ℓ does not appear in the metric because of general coordinate invariance that always reduces the length scale in the y' -direction.

The Klein decomposition gives rise to infinite tower of fields

$$\begin{aligned} \mathcal{G}_{mn}(x^m, y') &= \sum_{k=-\infty}^{\infty} \mathcal{G}_{mn}^{[k]}(x^m) e^{iky'/\ell}, \\ \mathcal{C}_{mnpq}(x^m, y') &= \sum_{k=-\infty}^{\infty} \mathcal{C}_{mnpq}^{[k]}(x^m) e^{iky'/\ell}, \\ \mathcal{G}_{mnpqy'}(x^m, y') &= \sum_{k=-\infty}^{\infty} \mathcal{G}_{mnpqy'}^{[k]}(x^m) e^{iky'/\ell}, \\ r(x^m, y') &= \sum_{k=-\infty}^{\infty} r^{[k]}(x^m) e^{iky'/\ell}. \end{aligned} \quad (2.15)$$

Since we have the invariant ‘geodesic’ radius ℓr as eigenvalue of momentum operator in the eleven dimensions, each mode has KK mass

$$M_k^2 = \frac{k^2}{\ell^2 \langle r \rangle^2}. \quad (2.16)$$

In the effective eleven-dimensional action (2.18), we keep the zero mode in the action after renaming

$$G_{mn}(x^m) \equiv \mathcal{G}_{mn}^{[0]}(x^m), \quad C_{mnp}(x^m) \equiv (r^{[0]})^{-1} \mathcal{C}_{mnp}^{[0]}(x^m), \quad G_{mnpq}(x^m) \equiv (r^{[0]})^{-1} \mathcal{G}_{mnpq}^{[0]}(x^m),$$

and truncate the other massive modes $k \neq 0$ of masses (2.16) considering small r limit.² This is consistent with the relation (2.6). These modes will be interpreted as wrapping mode of M2-branes later.

It should be noted that although the zero modes of \mathcal{C}_4 and \mathcal{G}_5 consistently give the eleven-dimensional fields and their field strengths C_3 and G_4 , it cannot be said that we could derive the eleven-dimensional fields by reduction. In fact we have defined the former in terms of the latter by multiplying $r(x^m, y')$. Therefore at best we can check that we have the correct field degrees of freedom. This is because this dynamics is due to the behavior of the M2-branes and cannot be completely explained by this field theory limit (for example in the string picture, this is related to winding string in the T -dual theory).

Now consider the action. The first two terms in (2.3) give

$$\frac{1}{2\kappa_{12}^2} \int_{12D} d^{12}x \sqrt{-\mathcal{G}} \left(\mathcal{R} - \frac{1}{2} |\mathcal{G}_5|^2 \right) = \frac{1}{2\kappa_{12}^2} \int_{S^1} dy' \int_{11D} d^{11}x \sqrt{-Gr} \left(R - \frac{1}{2} |G_4|^2 \right),$$

with a total derivative of a function of r , which can be removed by an appropriate boundary condition. Further compactification and consideration in lower dimensional theory shall later require the condition for r . After settling down everything we may consider the vacuum expectation value of r . With this, we define κ_{12} in terms of κ_{11} in (2.18),

$$\frac{2\pi\ell\langle r \rangle}{2\kappa_{12}^2} = \frac{1}{2\kappa_{11}^2}. \tag{2.17}$$

In this process, we may learn that the definition of \mathcal{G}_5 in (2.5) is the only possibility to give the desired kinetic term for C_3 , while the other seemingly plausible choice $\mathcal{G}_5 = d\mathcal{C}_4$ cannot. Note that the Chern-Simons action (2.10) also gives rise exactly the same factor as in (2.17). Therefore, we have obtained the bosonic part of the eleven-dimensional supergravity action

$$2\kappa_{11}^2 S = \int d^{11}x \sqrt{-G} \left(R - \frac{1}{2} |G_4|^2 \right) - \frac{1}{6} \int C_3 \wedge G_4 \wedge G_4, \tag{2.18}$$

The action (2.18) is also regarded as a low-energy, field-theoretical, effective action of M-theory, in the limit that the fundamental object of M2-brane becomes pointlike. Therefore, we should have more irrelevant interaction operators at higher energies. Some of them are provided by Kaluza-Klein (KK) towers of fields in (2.15).

We have a scalar field r , which may raise two questions. First, this would exceed the desired degree of freedom of eleven-dimensional supergravity, failing to form the supersymmetric multiplet. We will see later that this will be related to the other components of the graviton. Also, it is questionable whether the action is consistent in eleven and twelve dimensions in the sense that the resulting Einstein equation is solvable. It is known that simply turning off the scalar in the dimensional reduction of pure gravity is inconsistent [40]. In particular what concerns us is the $y'y'$ component of the twelve-dimensional Einstein equation. In our case, we are turning off the vector field while keeping the scalar field, and this is even possible from pure gravity, as a special case of Brans-Dicke theory [46].

²As long as there is no confusion, we use the same letters C_3, G_4 for the twelve dimensional fields $C_3(x^M), G_4(x^M)$ and their eleven-dimensional zero modes $C_3(x^m), G_4(x^m)$.

Since we are not dealing with pure gravity, but we have source terms through \mathcal{C}_4 from the third and the last terms on the right-hand side (r.h.s.) of (2.3), it seems always possible to satisfy the equation.

3 Reduction to the IIB bosonic action

We cannot obtain IIB string theory by direct dimensional reduction of the twelve-dimensional theory, which directly yielded eleven-dimensional supergravity, because the resulting ten-dimensional geometry is partially described by components of the antisymmetric tensor field \mathcal{C}_4 . The notion of graviton should be drastically changed. We shall observe this feature by taking the following description. Starting from the eleven-dimensional supergravity action in the previous section, further toroidal compactification gives a unique nine-dimensional supergravity action of thirty-two supercharges. It can be understood as compactification of IIB supergravity, whose decompactification is to be described dynamically.

3.1 Nine dimensional geometry

On top of the reduction of section 2.2 to eleven-dimensional supergravity, we compactify further two dimensions on a torus with a complex structure

$$\tau = \tau_1 + i\tau_2. \tag{3.1}$$

This is done by identifying two coordinates as

$$x \sim x + 2\pi\ell \sim x + \tau y + 2\pi\tau\ell,$$

with the length unit ℓ used in (2.14). The observed lengths are always given in combination of the metric

$$ds^2 = L^2(dx + \tau_1 dy + (a_\mu - \tau_1 b_\mu) dx^\mu)^2 + L^2\tau_2^2(dy - b_\mu dx^\mu)^2 + r^2 dy'^2 + g'_{\mu\nu} dx^\mu dx^\nu. \tag{3.2}$$

It is the most general metric leaving the y' direction orthogonal. Here, the metric components a_μ and b_μ are now Lorentz vectors in nine dimension, promoting the S^1 isometries of the x and y directions, respectively, to $U(1)$ gauge symmetries.

In the classical theory, this torus has $SL(2, \mathbb{R})$ symmetry due to diffeomorphism invariance. This is the reason why the coordinate radius ℓ does not appear in the metric (3.2). If a quantum theory of gravity breaks the scale invariance and set the fundamental length ℓ , then we would have just $SL(2, \mathbb{Z})$, generated by $\tau \rightarrow \tau + 1$ and $\tau \rightarrow -1/\tau$. This is what happens in Type IIB string theory or F-theory [24]. String quantization reduces the continuous internal symmetry to discrete. Now the origin of $SL(2, \mathbb{R})$ symmetry of type IIB theory is identified as the symmetry of the torus. Thus τ is also interpreted as the complex structure and transforms under this modular group. The pair $A_{\mu\nu}, B_{\mu\nu}$ originate from the dimensional reduction of \mathcal{C}_4 one of whose coordinates are respectively fixed to be y and x .

To facilitate calculation, we introduce zwölfbeins [51]. By rewriting the metric (3.2)

$$\mathcal{G}_{MN} = L^2 \begin{pmatrix} L^{-2}g'_{\mu\nu} + R_\mu R_\nu + I_\mu I_\nu & \tau_1 R_\mu + \tau_2 I_\mu & R_\mu & 0 \\ \tau_1 R_\nu + \tau_2 I_\nu & \tau_1^2 + \tau_2^2 & \tau_1 & 0 \\ R_\nu & \tau_1 & 1 & 0 \\ 0 & 0 & 0 & L^{-2}r^2 \end{pmatrix}, \quad (3.3)$$

where $R_\mu = a_\mu - \tau_1 b_\mu$, $I_\mu = -\tau_2 b_\mu$ and the bases of the block submatrices are understood, we obtain

$$e_M^A = \begin{pmatrix} e_\mu^\alpha & 0 & 0 & 0 \\ -LI_\mu & L\tau_2 & 0 & 0 \\ LR_\mu & L\tau_1 & L & 0 \\ 0 & 0 & 0 & r \end{pmatrix}, \quad G_{MN} = e_M^A e_N^B \eta_{AB}, \quad (3.4)$$

where $\eta_{AB} = \text{diag}(-1, 1, 1, \dots, 1)$ is a rank twelve c -number matrix. It is useful to define its inverse,

$$E_A^M = \begin{pmatrix} E_\alpha^\mu & 0 & 0 & 0 \\ b_\alpha & (L\tau_2)^{-1} & 0 & 0 \\ -a_\alpha & -\tau_1(L\tau_2)^{-1} & L^{-1} & 0 \\ 0 & 0 & 0 & r^{-1} \end{pmatrix}, \quad e_M^A E_B^M = \delta_B^A. \quad (3.5)$$

For applying the metric, it is convenient to work in local Lorentz frame by using zwölfbeins,

$$\begin{aligned} \mathcal{C}_{ABCD} &= \mathcal{G}_{MNPQ} E_A^M E_B^N E_C^P E_D^Q, \\ \mathcal{G}_{EABCD} &= \mathcal{G}_{LMNPQ} E_E^L E_A^M E_B^N E_C^P E_D^Q. \end{aligned} \quad (3.6)$$

Then the fields in (3.6) are invariant under the gauge symmetries originating from the isometries. In fact, due to eleven-dimensional structure and the block-diagonal form of the zwölfbein (3.5), we will always consider the case with $E_D^Q = E_{y'}^{y'} = r^{-1}$. After the reduction, in the low dimension, we can recover the curved index structure by multiplying the vielbein.

3.2 Field reduction and decompactification

The nine-dimensional fields are obtained by reduction of the four-form field and the metric tensor in twelve dimension, as in table 1. The normalization is more natural if we start from eleven-dimensional supergravity, but the tensor structure of the four-form field A_4 is more natural in twelve-dimensions.

First, a rank two form field in the Neveu-Schwarz-Neveu-Schwarz (NSNS) comes from the following zero modes

$$\mathcal{C}_{\mu\nu xy'} \equiv -r B_{\mu\nu}, \quad \mathcal{G}_{\mu\nu\rho xy'} \equiv -r H_{\mu\nu\rho} = -3r \partial_{[\mu} B_{\nu\rho]}, \quad (3.7)$$

We are using the standard antisymmetric tensor notation by square brackets [45]. We have to take $L \rightarrow 0$ to decouple the degrees of freedom depending on x and y .

For example, consider

$$\begin{aligned} \mathcal{G}_{\alpha\beta\gamma xy'} &= \mathcal{G}_{[\mu\nu\rho]xy'} E_\alpha^\mu E_\beta^\nu E_\gamma^\rho E_x^x E_{y'}^{y'} + 3\mathcal{G}_{[\mu\nu y]xy'} E_\alpha^\mu E_\beta^\nu E_\gamma^y E_x^x E_{y'}^{y'} \\ &= L^{-1}(H_{\alpha\beta\gamma} + 3b_{[\alpha} H_{\beta\gamma]}), \end{aligned} \quad (3.8)$$

After decompactifying y' or y directions ten-dimensional Lorentz covariance is recovered. Also their magnetic dual fields follows from Hodge duality in twelve-dimension [1].

where

$$H_{\alpha\beta} \equiv 2\partial_{[\alpha}K_{\beta]}. \quad (3.9)$$

The relation in the parenthesis in (3.8) can be recasted as

$$\begin{aligned} H_{\alpha\beta\gamma} + 3b_{[\alpha}H_{\beta\gamma]} &= H_{\alpha\beta\gamma} + 6b_{[\alpha}\partial_{\beta]}K_{\gamma]} \\ &= H_{\alpha\beta\gamma} + 6K_{[\alpha}\partial_{\beta]}b_{\gamma]} + 6\partial_{[\alpha}(K_{\beta]}b_{\gamma]} \\ &= H_{\alpha\beta\gamma} + 3K_{[\alpha}h_{\beta\gamma]} \end{aligned} \quad (3.10)$$

In the last line, the total derivative is a gauge symmetry of $H_{\alpha\beta\gamma}$. Now, the form (3.10) can be regarded as arisen one from compactification of IIB supergravity

$$H_{\mu\nu\rho}^{(10)} = H_{\mu\nu\rho}, \quad H_{\mu\nu y'}^{(10)} = h_{\mu\nu} \equiv 2\partial_{[\mu}b_{\nu]}, \quad b_\alpha = rB_{\alpha y'}^{(10)}, \quad (3.11)$$

using the metric

$$\begin{aligned} ds^2 &= L^2(dx + \tau_1 dy)^2 + L^2\tau_2^2 dy^2 + r^2(dy' + K_\mu dx^\mu)^2 + g'_{\mu\nu} dx^\mu dx^\nu \\ &\Rightarrow L^2(dx + \tau_1 dy)^2 + L^2\tau_2^2 dy^2 + G'_{\mu\nu} dx^\mu dx^\nu. \end{aligned} \quad (3.12)$$

The justification is highly nontrivial, but we observe the following footprints whenever we perform dimensional reduction as in (3.2).

1. A U(1) gauge boson, usually called KK gauge boson, becomes a component of graviton in the extra dimension. This means, the ten-dimensional metric is re-arranged to include the vector field $K_\mu = r^{-1}\mathcal{C}_{\mu x y y'}$, gauging the isometry in the y' direction.
2. Appropriate additional terms for every reduced field coupled with KK gauge boson, by which the ten-dimensional fields are fully covariant. This condition *dictates* us to (from) which direction the (de)compactification takes place.

3. The tower of the KK states for every reduced field. In this case, we need towers of $g_{\mu\nu}^k(x^\mu)$, $B_{\mu\nu}^k(x^\mu)$, $b_\mu^k(x^\mu)$, $K_\mu^k(x^\mu)$ with exactly the same mass squared $k^2(\langle r \rangle \ell)^{-2}$ to each other. They exist because all of them come from the reduction of twelve-dimensional fields (2.15) with the physical y' -direction.

What is special in this case of dimensional reduction of twelve-dimensional supergravity is the following. For the first condition, the KK gauge boson K_μ did not come from dimensional reduction of higher dimensional graviton a_μ or b_μ , but from antisymmetric tensor field $\mathcal{C}_{\mu xy y'}$. For this, we may interpret that the metric tensor itself is *not observable*, but indirectly measurable only by interaction with other fields. This is related to the second condition: Besides the original y -direction from which we got KK gauge boson b_μ , we have shown in (3.10) that the nine dimensional theory has another *another* y' -direction to which we can decompactify with K_μ . We will see later that these two decompactifications are exclusive. For the third condition, the decompactification does not happen if we start from ten-dimensional IIA or the eleven-dimensional supergravities, since the KK states are missing. However they provide at best indirect evidences of the presence of the limit of uncompact y' -direction recovering ten-dimensional Lorentz symmetry. The only plausible option at the moment seems to be the formulation of type IIB string theory in ten dimensions, independent of the formulation of M-theory.

Now we perform dimensional reduction for Ramond-Ramond (RR) four-form as

$$A_{\mu\nu\rho y'} \equiv r^{-1} \mathcal{C}_{\mu\nu\rho y'}, \quad F_{\mu\nu\rho\sigma y'} = 4\partial_{[\mu} A_{\nu\rho\sigma] y'} \equiv r^{-1} \mathcal{G}_{\mu\nu\rho\sigma y'} \quad (3.13)$$

but only a part of it: one of whose index is fixed in the y' direction. Applying the same procedure, we have

$$\begin{aligned} \mathcal{G}_{\alpha\beta\gamma\delta y'} &= \mathcal{G}_{\mu\nu\rho\sigma y'} E_\alpha^\mu E_\beta^\nu E_\gamma^\rho E_\delta^\sigma E_{y'}^{y'} + 4\mathcal{G}_{\mu\nu\rho x y'} E_\alpha^\mu E_\beta^\nu E_\gamma^\rho E_\delta^x E_{y'}^{y'} + 4\mathcal{G}_{\mu\nu\rho y y'} E_\alpha^\mu E_\beta^\nu E_\gamma^\rho E_\delta^y E_{y'}^{y'} \\ &\quad + 12\mathcal{G}_{\mu\nu x y y'} E_\alpha^\mu E_\beta^\nu E_\gamma^x E_\delta^y E_{y'}^{y'} \\ &= F_{[\alpha\beta\gamma\delta] y'} + 4a_{[\alpha} H_{\beta\gamma\delta]} - 4b_{[\alpha} F_{\beta\gamma\delta]} + 12a_{[\alpha} b_{\beta} H_{\gamma\delta]} \\ &= F_{[\alpha\beta\gamma\delta] y'} + 4a_{[\alpha} H_{\beta\gamma\delta]} - 4b_{[\alpha} F_{\beta\gamma\delta]} + 12a_{[\alpha} K_{\beta} h_{\gamma\delta]} - 12b_{[\alpha} K_{\beta} f_{\gamma\delta]} \\ &= F_{[\alpha\beta\gamma\delta] y'} + 2a_{[\alpha} (H_{\beta\gamma\delta]} + 3K_{\beta} h_{\gamma\delta]) + 3f_{[\alpha\beta} (B_{\gamma\delta]} + 2K_{\gamma} b_{\delta]} \\ &\quad - 2b_{[\alpha} (F_{\beta\gamma\delta]} + 3K_{\beta} f_{\gamma\delta]) - 3h_{[\alpha\beta} (A_{\gamma\delta]} + 2K_{\gamma} a_{\delta]}), \end{aligned} \quad (3.14)$$

where we defined

$$f_{\alpha\beta} \equiv 2\partial_{[\alpha} a_{\beta]}, \quad h_{\alpha\beta} \equiv 2\partial_{[\alpha} b_{\beta]}.$$

The result shows that we have the same dimensionally reduced structure as in (3.10), satisfying the above three conditions. Note that the seemingly inverted relations (3.17) are because they are relations of local flat space. Rewriting the metric into the inverse *zehnbein*, obtained from the ten-dimensional metric (3.12)

$$E_\alpha^\mu = \begin{pmatrix} E_\alpha^\mu & 0 \\ K_\alpha & r^{-1} \end{pmatrix}, \quad (3.15)$$

we can easily calculate

$$\begin{aligned} F_{\alpha\beta\gamma\delta y'}^{(10)} &= E_\alpha^\mu E_\beta^\nu E_\gamma^\rho E_\delta^\sigma E_{y'}^{y'} F_{\mu\nu\rho\sigma y'}^{(10)} \\ &= r^{-1} F_{\alpha\beta\gamma\delta y'}, \end{aligned} \tag{3.16}$$

where the field in the last line is nine-dimensional. Likewise we obtain well-known relations between antisymmetric tensor fields [47, 48]

$$a_\alpha = r A_{\alpha y'}^{(10)}, \quad A_{\alpha\beta} + 2a_{[\alpha} K_{\beta]} = A_{\alpha\beta}^{(10)}, \quad B_{\alpha\beta} + 2b_{[\alpha} K_{\beta]} = B_{\alpha\beta}^{(10)}, \tag{3.17}$$

and similar for their field strengths. Therefore, rewriting (3.14) we have

$$\begin{aligned} r(F_{[\alpha\beta\gamma\delta]y'}^{(10)} + 2A_{y'[\alpha} H_{\beta\gamma\delta]}^{(10)} - 3A_{[\alpha\beta} H_{\gamma\delta]y'}^{(10)} - 2B_{y'[\alpha} F_{\beta\gamma\delta]}^{(10)} + 3B_{[\alpha\beta} F_{\gamma\delta]y'}^{(10)}) \\ = r \left(F_5^{(10)} - \frac{1}{2} A_2^{(10)} \wedge H_3^{(10)} + \frac{1}{2} B_2^{(10)} \wedge F_3^{(10)} \right)_{[\alpha\beta\gamma\delta]y'} \\ \equiv r \tilde{F}_{[\alpha\beta\gamma\delta]y'}^{(10)}, \end{aligned} \tag{3.18}$$

using the metric (3.12), recovering the total antisymmetric structure. The complete antisymmetric structure comes from total antisymmetrization of \mathcal{C}_4 and \mathcal{G}_5 , which is only possible in twelve-dimensional lift. For this special four-form field, we need the other component to recover ten-dimensional Poincaré symmetry. Since \mathcal{C}_4 can at best give rank four field in ten dimensions, we consider its magnetic dual field in the next subsection. Other components are dimensionally reduced in similar fashion, shown in the appendix.

3.3 Self-duality of the IIB four-form field

We have seen that the Hodge duality of \mathcal{G}_5 in (2.12) defined the six-form C_6 . In this, total antisymmetric tensor in Hodge duality relation in twelve-dimension prevented the C_6 from taking an index on y' . With three compactified directions along x, y, y' , the four-form field A_4 is obtained only by fixing two indices of the C_6 to be on x and y ,

$$C_{\mu\nu\rho\sigma xy} \equiv A_{\mu\nu\rho\sigma}, \quad F_{\mu\nu\rho\sigma\tau} \equiv 5\partial_{[\mu} A_{\nu\rho\sigma\tau]}. \tag{3.19}$$

Again we emphasize that this C_6 is *defined* through the twelve-dimensional Hodge duality (2.12), or in components (2.13). To perform dimensional reduction, we go to local Lorentz frame in which $\sqrt{-\mathcal{G}} = 1$ and $\mathcal{G}_{AB} = \eta_{AB}$. Going to nine dimension and performing decompactification to ten dimensions, the right-hand side of (2.13) gives what we have just computed in (3.18)³

$$\frac{1}{5!} \epsilon_{\alpha_1\alpha_2\dots\alpha_9 x y y'} r \tilde{F}_{\alpha_6\alpha_7\alpha_8\alpha_9 y'}^{(10)} = r *_{10} \tilde{F}_{\alpha_1\alpha_2\alpha_3\alpha_4\alpha_5}^{(10)}. \tag{3.20}$$

Taking into account the factors $E_x^x = L^{-1}$, $E_y^y = (L\tau_2)^{-1}$, the left-hand side (l.h.s.) of (2.13) becomes

$$\left(F_{\alpha_1\alpha_2\alpha_3\alpha_4\alpha_5} - \frac{1}{2} (C_3 \wedge G_4)_{[\alpha_1\alpha_2\alpha_3\alpha_4\alpha_5]xy} \right) L^{-2} \tau_2^{-1} \tag{3.21}$$

³Note that there is cancellation between r in the definition of $rF_{\mu\nu\rho\sigma y'}$ and $E_{y'}^{y'}$ in the nine-dimensional relation, there is another r factor as in (3.18), in going to ten dimension.

which is a nine-dimensional relation. Componentwise calculation gives

$$C_3 \wedge G_4|_{xy} = -B_2 \wedge F_3 + A_2 \wedge H_3 + K_1 \wedge G_4 + A_3 \wedge H_2. \quad (3.22)$$

It immediately follows that

$$\left(G_7 - \frac{1}{2} C_3 \wedge G_4 \right) \Big|_{xy} = F_5^{(10)} - \frac{1}{2} A_2^{(10)} \wedge H_3^{(10)} + \frac{1}{2} B_2^{(10)} \wedge F_3^{(10)} \equiv \tilde{F}_5^{\text{wo}(10)}$$

with all the indices different from x, y, y' .

Now, different components of the F_5 came from different forms \mathcal{C}_4 and C_6 , therefore the Lorentz covariance of the F_5 is not trivial. Comparing the l.h.s. and the r.h.s., we find that the covariance we need is the same coefficients

$$r = L^{-2} \tau_2^{-1}. \quad (3.23)$$

That is, the new degree of freedom turns out to be not independent. In terms of the vielbein, we have an emergent component

$$e_{y'}^{y'} = (e_x^x e_y^y)^{-1}. \quad (3.24)$$

The condition (3.23) can be only the necessary condition for the relation (3.24), but later we will see that indeed we need the condition (3.24).

Summarizing, we have *defined* the four form field A_4 and its field strength F_5 via twelve-dimensional duality relation and dimensional reduction. This is expressed as

$$\tilde{F}_5^{\text{wo}(10)} = *_{10} \tilde{F}_5^{\text{w}(10)}, \quad (3.25)$$

where $*_{10}$ is the Hodge dual operator in ten dimension and

$$\begin{aligned} \tilde{F}_5^{\text{w}(10)} &\equiv \frac{1}{4!} \tilde{F}_{\mu\nu\rho\sigma y}^{(10)} dx^\mu \wedge dx^\nu \wedge dx^\rho \wedge dx^\sigma \wedge dy', \\ \tilde{F}_5^{\text{wo}(10)} &= \frac{1}{5!} \tilde{F}_{\mu\nu\rho\sigma\tau}^{(10)} dx^\mu \wedge dx^\nu \wedge dx^\rho \wedge dx^\sigma \wedge dx^\tau, \end{aligned} \quad (3.26)$$

with all the indices nine-dimensional. This only happens in this special circumstance in which the numbers of degrees are related as

$$\frac{1}{2} \cdot \frac{8 \cdot 7 \cdot 6 \cdot 5}{4 \cdot 3 \cdot 2 \cdot 1} = \frac{7 \cdot 6 \cdot 5}{3 \cdot 2 \cdot 1} = \frac{7 \cdot 6 \cdot 5 \cdot 4}{4 \cdot 3 \cdot 2 \cdot 1}.$$

This is equivalent to ten-dimensional self-duality relation using full ten-dimensional one.

In fact, this means the unprimed version should also hold

$$\tilde{F}_5^{(10)} = *_{10} \tilde{F}_5^{(10)} \quad (3.27)$$

where

$$\tilde{F}_5^{(10)} \equiv \frac{1}{5!} \tilde{F}_{\mu\nu\rho\sigma\tau}^{(10)} dx^\mu \wedge dx^\nu \wedge dx^\rho \wedge dx^\sigma \wedge dx^\tau \equiv \tilde{F}_5^{\text{w}(10)} + \tilde{F}_5^{\text{wo}(10)} \quad (3.28)$$

has the full dependence on ten-dimensions $\mu, \dots, \tau = 0, 1, \dots, 9$. The equation of motion and the Bianchi identity from this are

$$d\tilde{F}_5^{(10)} = d*_{10}\tilde{F}_5^{(10)} = H_3^{(10)} \wedge F_3^{(10)}, \quad (3.29)$$

with now the full ten-dimensional index structure.

3.4 Couplings and scales

Dimensional reduction of the Einstein-Hilbert term goes as follows. We compactify three dimensions using the metric (3.2)

$$\sqrt{-\mathcal{G}}\mathcal{R} = \sqrt{-g'_{(9)}}rL^2\tau_2 \left(R_{(9)} - 2(L\tau_2)^{-1}\nabla^2(L\tau_2) - \frac{1}{2}\tau_2^{-2}(\partial_\mu\tau_1)^2 - 2L^{-1}\nabla^2L - \frac{1}{4}L^2\tilde{f}_{\mu\nu}^2 - \frac{1}{4}L^2\tau_2^2h_{\mu\nu}^2 \right). \quad (3.30)$$

Here, $\tilde{f}_{\mu\nu} \equiv f_{\mu\nu} - Ah_{\mu\nu}$. The overall factor becomes $rL^2\tau_2 = 1$ by (3.23). The last two terms provides the kinetic terms for the dimensionally reduced components of $\tilde{F}_{\mu\nu y'}$ and $H'_{\mu\nu y'}$ in (3.11). Using the identity (B.24) in the appendix, this can be recollected as

$$\sqrt{-g'_{(9)}} \left(R_{(9)} - 2r^{-1}\nabla r + 4\tau_2^{-2}(\partial_\mu\tau_2)^2 - \frac{1}{4}\tau_2^{-2}(\partial_\mu\tau_1)^2 \right). \quad (3.31)$$

With the term (B.10), this is nothing but the dimensional reduction of ten-dimensional type IIB action

$$\sqrt{-g_{(10)}}r^{-1} \left(R_{(10)} + \frac{4}{\tau_2^2}(\partial_\mu\tau_2)^2 - \frac{1}{4\tau_2^2}(\partial_\mu\tau_1)^2 \right). \quad (3.32)$$

with the decompactified metric (3.12).

Identifying that $\tau_2 = g_{\text{IIB}}^{-1}$ we would require L should be absent in the ten-dimensional IIB action, which could be expected by counting degrees of freedom. We can show that the only way to remove L in the action is to absorb $r = L^{-2}\tau_2^{-1}$ in the coupling and to rescale

$$g_{\mu\nu}^{(10)} \equiv L^{-1}g_{\mu\nu}^{(10)}. \quad (3.33)$$

Accordingly, we have $\sqrt{-g'_{(10)}} = \sqrt{-g_{(10)}}L^{-5}$, and $R^{(10)} \rightarrow LR^{(10)}$ up to a kinetic term for L . This fixes the ten-dimensional IIB gravitational coupling in terms of the eleven-dimensional coupling κ_{11} , which may be a more fundamental quantity than κ_{12} ,

$$\frac{1}{2\kappa_{\text{IIB}}^2} = \frac{(2\pi\ell)^2\langle r \rangle}{2\kappa_{12}^2} = \frac{2\pi\ell}{2\kappa_{11}^2}. \quad (3.34)$$

This is also useful in the decompactification limit $r \rightarrow \infty$, since this can be taken as $L \rightarrow 0$ while keeping κ_{11} fixed and the IIB coupling should be free parameter.

The rescaling (3.33) should also rescale the coordinate periodicity as

$$\ell \rightarrow L^{-1/2}\ell \equiv \ell_s, \quad (3.35)$$

in which unit we can naturally convert between IIA and IIB theories in ten dimensions. The relation between the two radii from (3.12) in the new unit are now

$$R_y = L^{3/2}\tau_2\ell_s, \quad R_{y'} = \frac{\ell_s}{L^{3/2}\tau_2} = \frac{\ell_s^2}{R_y}. \quad (3.36)$$

Finally we reduce the Chern-Simons term (2.10). Since this coupling is topological we do not care about the metric and we keep the general indices. First we note that \mathcal{G}_5 should

always have an index on y' , becoming F_5^w . The other part, $C_3 \wedge G_4$, should have two indices on x and y . It has exactly the expansion (3.22). Noting that $\int_{T^2} dx \wedge dy = (2\pi\ell)^2$, we obtain

$$\begin{aligned}
 S_{\text{CS}} &= \frac{(2\pi\ell)^2}{4\kappa_{12}^2} \int_{10} r F_5^{(9)w} \wedge (B_2^{(9)} \wedge F_3^{(9)} - A_2^{(9)} \wedge H_3^{(9)} - K_1^{(9)} \wedge G_4^{(9)} - A_3^{(9)} \wedge H_2^{(9)}) \\
 &= \frac{1}{4\kappa_{\text{IIB}}^2} \int F_5^{(10)w} \wedge (B_2^{(10)} \wedge F_3^{(10)} - A_2^{(10)} \wedge H_3^{(10)}) \\
 &= \frac{1}{2\kappa_{\text{IIB}}^2} \int F_5^{(10)w} \wedge B_2^{(10)} \wedge F_3^{(10)}.
 \end{aligned} \tag{3.37}$$

The integration is done over the remaining ten dimension including the y' -direction. We performed integration by parts in the last line.

3.5 Ten-dimensional covariant action

We are now in a position to write down the action of type IIB supergravity in ten dimension. We obtained it by using compactification and also decompactification of already compact direction. If we give up covariant formulation, nevertheless the Poincaré symmetry is to be recovered, the ten-dimensional action can be written as dimensionally reduced form from the twelve-dimensional one as follows.

$$-\frac{1}{4\kappa_{12}^2} \int d^{12}x \sqrt{-\mathcal{G}} \mathcal{G}_{\alpha\beta\gamma\delta y'}^2 = -\frac{1}{4\kappa_{\text{IIB}}^2} \int d^{10}x \sqrt{-g} |\tilde{F}_5^w|^2, \tag{3.38}$$

$$-\frac{1}{4\kappa_{12}^2} \int d^{12}x \sqrt{-\mathcal{G}} \mathcal{G}_{\alpha\beta\gamma xy'}^2 = -\frac{1}{4\kappa_{\text{IIB}}^2} \int d^{10}x \sqrt{-g} \tau_2^2 \left(|H_3|^2 - \frac{1}{2} h_{\alpha\beta}^2 \right), \tag{3.39}$$

$$-\frac{1}{4\kappa_{12}^2} \int d^{12}x \sqrt{-\mathcal{G}} \mathcal{G}_{\alpha\beta\gamma yy'}^2 = -\frac{1}{4\kappa_{\text{IIB}}^2} \int d^{10}x \sqrt{-g} \left(|\tilde{F}_3|^2 - \frac{1}{2} \tilde{f}_{\alpha\beta}^2 \right), \tag{3.40}$$

$$\frac{1}{12\kappa_{12}^2} \int C_4 \wedge G_4 \wedge G_4 = \frac{1}{2\kappa_{\text{IIB}}^2} \int F_5^w \wedge B_2 \wedge F_3, \tag{3.41}$$

$$\begin{aligned}
 &\frac{1}{2\kappa_{12}^2} \int d^{12}x \sqrt{-\mathcal{G}} \left(\mathcal{R} - \frac{1}{2} \mathcal{G}_{\alpha\beta xy y'}^2 \right) \\
 &= \frac{1}{2\kappa_{\text{IIB}}^2} \int d^{10}x \sqrt{-g} \tau_2^2 \left(R + 4(\partial_\mu \tau_2)^2 - \frac{1}{2} |F_1|^2 - \frac{1}{4} h_{\alpha\beta}^2 - \frac{1}{4} \tilde{f}_{\alpha\beta}^2 \right).
 \end{aligned} \tag{3.42}$$

All the fields here are ten-dimensional, so we suppress the superscript (10) appearing in those fields in the appendix. In particular \tilde{F}_5^w is defined in (3.26). Also, g is the determinant of the ten-dimensional metric, with which we calculate the Ricci scalar R . We have defined

$$\tilde{F}_3 = F_3 - A \wedge H_3, \quad F_1 = dA. \tag{3.43}$$

It is remarkable that, we do not lose ten-dimensional Poincaré invariance only with \tilde{F}_5^w , as long as it satisfies self-duality condition (3.27)

$$|\tilde{F}_5^w|^2 = \frac{1}{2} |\tilde{F}_5^w|^2 + \frac{1}{2} |\tilde{F}_5^{w0}|^2 = \frac{1}{2} |\tilde{F}_5|^2. \tag{3.44}$$

This is possible because either field contains the full physical degrees of freedom and satisfies the relation $|\tilde{F}_5^w|^2 = |\tilde{F}_5^{w0}|^2$ from the Hodge duality. The last term has manifest covariance,

but after plugging in the action, the normalization has an extra $\frac{1}{2}$ factor, as a footprint of self-dual degree of freedom.

The Chern-Simons term (3.41) has a special property

$$\int F_5^w \wedge B_2 \wedge F_3 = \int \left(F_5^w - \frac{1}{2} B_2 \wedge F_3 + \frac{1}{2} A_2 \wedge H_3 \right) \wedge B_2 \wedge F_3 = \int \tilde{F}_5^w \wedge B_2 \wedge F_3$$

where we have used the equality $F_3 \wedge F_3 = 0$ and done integration by parts. Use the definition (3.29) $\tilde{F}_5^w + \tilde{F}_5^{wo} = \tilde{F}_5$ and totally antisymmetric property $\tilde{F}_5^{wo} \wedge B_2 \wedge F_3 = 0$. We have

$$\frac{1}{12\kappa_{12}^2} \int \mathcal{C}_4 \wedge G_4 \wedge G_4 = \frac{1}{4\kappa_{\text{IIB}}^4} \int F_5 \wedge B_2 \wedge F_3, \tag{3.45}$$

with the full ten-dimensional invariance. We have finally recovered ten-dimensional Poincaré invariance in the action, but the self-duality condition is lost. We have to impose the condition after having the equation of motion.

4 The fermionic part and supersymmetry

In this section we embed the fermionic sector and look for supersymmetry transformations. It turns out that the fermionic degrees of freedom of eleven-dimensional supergravity suffice, because the components along the twelfth direction becomes emergent, as in the case of the bosonic counterpart in (3.24).

The most beneficial feature of twelve dimensional, and in general of $4n$ -dimensional, embedding is, we can exchange among Majorana and Weyl spinors of all the chiralities just using the property of the spacetime. Therefore we can exchange between parity preserving IIA supersymmetry generators with chiral IIB ones in twelve-dimensions.

4.1 Embedding in twelve dimension

We first summarize the properties of spinors for the agreement of notations. The ten-dimensional Clifford algebra is generated by ten matrices γ^α satisfying

$$\{\gamma^\alpha, \gamma^\beta\} = 2\eta^{\alpha\beta} \mathbf{1}_{32}, \quad \eta^{\alpha\beta} = \text{diag}(-1, 1, 1, \dots, 1) \tag{4.1}$$

with the rank-32 unit matrix $\mathbf{1}_{32}$. Under this a Dirac spinor ψ transforms and can be expressed in terms of two 16-complex-component spinors ψ_1 and ψ_2 as

$$\psi = \begin{pmatrix} \psi_1 \\ \psi_2 \end{pmatrix}, \tag{4.2}$$

to make up 32 components. Each component is a nine-dimensional Dirac.

We may impose Weyl or Majorana conditions, each of which reduces half the components. In ten dimension, both conditions can be imposed at the same time. The Weyl spinors are eigenstates of the chirality operator

$$\gamma^{10} = \prod_{\alpha=0}^9 \gamma^\alpha = \begin{pmatrix} \mathbf{1} & 0 \\ 0 & -\mathbf{1} \end{pmatrix}, \tag{4.3}$$

where $\mathbf{1}$ is the rank-16 unit matrix. We always have such a basis where γ^{10} takes this form. The Majorana spinor satisfies the ‘reality’ condition

$$\begin{pmatrix} \psi_1^* \\ \psi_2^* \end{pmatrix} = \begin{pmatrix} \psi_1 \\ \psi_2 \end{pmatrix}. \tag{4.4}$$

The spinor (4.2) can be readily promoted to an eleven-dimensional Dirac spinor having now the dependence on $x^m, m = 0, 1, \dots, 10$, if we use γ^{10} in (4.3) as the eleventh generator of the algebra (4.1). In this case, only the Majorana condition (4.4) can be imposed.

We should go to twelve dimension, in which a spinor has 64 components, and need another gamma matrix extending the Clifford algebra. We do this by extending the gamma matrices as

$$\Gamma^\alpha = \begin{pmatrix} -\gamma^\alpha & \\ & \gamma^\alpha \end{pmatrix}, \alpha = 0, \dots, 9, \quad \Gamma^x = \begin{pmatrix} & \mathbf{1} \\ \mathbf{1} & \end{pmatrix}, \quad \Gamma^{y'} = i \begin{pmatrix} & -\mathbf{1} \\ \mathbf{1} & -\mathbf{1} \\ & & \mathbf{1} \end{pmatrix}, \tag{4.5}$$

where γ^α are ten-dimensional gamma matrices. One can see that $\Gamma^\alpha, \Gamma^x, \Gamma^{y'}$ satisfy the commutation relations in a similar manner as (4.1). We cannot simply embed *eleven*-dimensional spinor ψ in twelve dimension, because we did not extended γ^{10} to the off-diagonal block matrix Γ^x , unlike other γ^α 's defined in the first of (4.5)

$$\begin{pmatrix} -\gamma^{10} & \\ & \gamma^{10} \end{pmatrix} \neq \Gamma^x.$$

Interestingly but not coincidentally the left-hand side is the twelve-dimensional chirality operator $-\Gamma$,

$$\begin{pmatrix} -\gamma^{10} & \\ & \gamma^{10} \end{pmatrix} = i\Gamma^x\Gamma^{y'} \prod_{\alpha=0}^9 \Gamma^\alpha = - \begin{pmatrix} \mathbf{1} & & \\ & -\mathbf{1} & \\ & & -\mathbf{1} \\ & & & \mathbf{1} \end{pmatrix} \equiv -\Gamma. \tag{4.6}$$

The remedy follows, if we require $\Gamma^x\Psi$ be compatible to ten-dimensional $\Gamma\Psi$ by making them proportional. Simple identification, however, does not give us a nontrivial embedding. A good choice is

$$\Gamma^x\Psi = i\Gamma\Psi. \tag{4.7}$$

This reduces the number of components to be half

$$\Psi = \begin{pmatrix} \psi_1 \\ \psi_2 \\ i\psi_1 \\ -i\psi_2 \end{pmatrix}. \tag{4.8}$$

This shows how do we embed the eleven-dimensional spinor (4.2) into twelve dimension with Lorentz signature (1, 11). Conversely, the twelve-dimensional spinor (4.8) decomposes into

$$\begin{array}{ccc}
 12\text{D} \begin{pmatrix} \psi_1 \\ \psi_2 \\ i\psi_1 \\ -i\psi_2 \end{pmatrix} & \Leftrightarrow & \begin{pmatrix} 0 \\ \psi_2 \\ i\psi_1 \\ 0 \end{pmatrix} \xrightarrow{S_y^1 \text{ compactification}} 11\text{D} \begin{pmatrix} \psi_1 \\ \psi_2 \end{pmatrix} \\
 \downarrow T^2 \simeq S_x^1 \times S_y^1 \text{ comp.} & & \downarrow S_x^1 \text{ comp.} \\
 \text{IIB} \begin{pmatrix} 0 \\ i\psi_1 \end{pmatrix} + \begin{pmatrix} 0 \\ \psi_2 \end{pmatrix} & \xleftarrow{\text{T-dual}} & \text{IIA} \begin{pmatrix} \psi_1 \\ 0 \end{pmatrix} + \begin{pmatrix} 0 \\ \psi_2 \end{pmatrix}
 \end{array}$$

Figure 2. Reduction of an eleven-dimensional Majorana spinor *embedded in twelve dimension*. In twelve dimension, a Majorana spinor is converted to Weyl spinor. Going to nine dimension and performing the decompactification, the gamma matrix structure forces the resulting total spinor to be a complex Weyl in ten dimension. Each entry ψ_1 or ψ_2 is nine-dimensional Majorana spinor having 16 real components.

two spinors (4.2) and $i\gamma^{10}$ times it, each of which describes the same dynamics, governed by the same equation.

Imposing twelve-dimensional Majorana condition (A.1) on the the spinor (4.8) reduces it to be eleven-dimensional Majorana, which is again interpreted as ten-dimensional Majorana, with purely real ψ_1 and ψ_2 .

Finally, it is always possible to name a coordinate to be y such that the corresponding γ -matrix in ten- and twelve-dimensions are respectively

$$\gamma^y = i \begin{pmatrix} 0 & -\mathbf{1} \\ \mathbf{1} & 0 \end{pmatrix}, \quad \Gamma^y = \begin{pmatrix} -\gamma^y & 0 \\ 0 & \gamma^y \end{pmatrix} = i \begin{pmatrix} \mathbf{1} & & \\ -\mathbf{1} & & \\ & & -\mathbf{1} \\ & & & \mathbf{1} \end{pmatrix}. \tag{4.9}$$

In the bosonic part, we have compactified this y -direction (as well as the x -direction) to have nine-dimensional action. This does a special operation

$$\gamma^y \begin{pmatrix} \psi_1 \\ \psi_2 \end{pmatrix} = \begin{pmatrix} -i\psi_2 \\ i\psi_1 \end{pmatrix} \tag{4.10}$$

exchanging the chirality of ten-dimensional Weyls. Exchanging the chirality made possible after compactifying the y -direction, because we do not have ten-dimensional chirality in nine-dimensions.

4.2 Generalized local supersymmetry transformations

For the fermionic part of the supergravity, we start with the Rarita-Schwinger action for the gravitino Ψ_m

$$S_{\text{RS}} = -\frac{1}{4\kappa_{12}^2} \int d^{11}x dy' \sum_{m,n,p=0}^{10} i\bar{\Psi}_m \Gamma^{mnp} \partial_n \Psi_p,$$

with the usual Dirac conjugate $\bar{\Psi}_m = \Psi_m^\dagger \Gamma^0$ with an appropriate choice of Γ^0 and antisymmetrized Γ -matrices

$$\Gamma^{mnp} = \Gamma^{[m} \Gamma^n \Gamma^{p]}$$

We have only eleven-dimensional Poincaré invariance in the beginning. Since we have only 11 derivative terms, time evolution does not ruin the embedded form, and the physics is the same as eleven-dimensional supergravity. Therefore, from a twelve-dimensional spinor, which is not fully Lorentz covariant but is only under eleven-dimensional, we can obtain the following by truncation to ten dimension.

We require the *eleven*-dimensional local supersymmetry, expressed in terms of the spinors and gamma matrices embedded in the twelve dimension as above. Then keeping the half of the components,

$$\mathcal{E} = \begin{pmatrix} \epsilon_1 \\ \epsilon_2 \\ i\epsilon_1 \\ -i\epsilon_2 \end{pmatrix} \rightarrow \begin{pmatrix} \epsilon_1 \\ \epsilon_2 \end{pmatrix}, \quad \epsilon_1, \epsilon_2 \text{ real}, \quad (4.11)$$

we obtain the eleven-dimensional supergravity. Therefore the natural extension is

$$\begin{aligned} \delta e_m^a &= \frac{1}{2} \bar{\mathcal{E}} \Gamma^a \Psi_m \\ &= \bar{\epsilon} \Gamma^a \Psi_m \end{aligned} \quad (4.12)$$

$$\begin{aligned} \delta \mathcal{C}_{mnp\underline{y}'} &= -\frac{3r}{2} \bar{\mathcal{E}} \Gamma_{[mn} \Psi_{p]} = -\frac{1}{2} \bar{\mathcal{E}} \Gamma^{y'} \Gamma_{[y' mn} \Psi_{p]} \\ &= -3\bar{\epsilon} \Gamma_{[mn} \Psi_{p]}, \end{aligned} \quad (4.13)$$

$$\begin{aligned} \delta \Psi_m &= \left(\nabla_m + \frac{1}{288} (\mathcal{G}_{npq\underline{y}'} \Gamma_m \Gamma^{npqr} - 12 \mathcal{G}_{mnpq\underline{y}'} \Gamma^{npq}) \right) \mathcal{E} \\ &= \left(\nabla_m + \frac{1}{288} (G_{npqr} \Gamma_m \Gamma^{npqr} - 12 G_{mnpq} \Gamma^{npq}) \right) \epsilon. \end{aligned} \quad (4.14)$$

The only difference is coordinate dependence, that is all $f(x^m)$ are changed as $f(x^m, y)$, while the tensor structure is intact. In this section, the underlined coordinate values are that of general spacetime, whereas plane coordinates are local flat ones. All the indices are eleven-dimensional, different from y' , and $\bar{\mathcal{E}} = \mathcal{E}^\dagger \Gamma^0$. We note that although the degree is enhanced, there is no extra transformation than those of eleven-dimensional supergravity. The transformation of zwölfbein takes the form

$$\delta e_\mu^\alpha = \frac{1}{2} \bar{\mathcal{E}} \Gamma^\alpha \Psi_\mu, \quad \delta e_{\underline{x}}^x = \frac{1}{2} \bar{\mathcal{E}} \Gamma^x \Psi_{\underline{x}}, \quad \delta e_{\underline{y}}^y = \frac{1}{2} \bar{\mathcal{E}} \Gamma^y \Psi_{\underline{y}}, \quad (4.15)$$

which are merely re-expressing the original rules.

We have seen in (3.24) that the components of the graviton in the y' -direction emerge from a combination of components in the other directions. Likewise, we do not require the presence of the component $\Psi_{y'}$ along the twelfth direction, but it will emerge later after decompactification. In fact, a would-be independent component $\Psi_{y'}$ would have resulted in an extra component of graviton whose helicity exceeds 2 in the four dimensional language, which is inconsistent.

4.3 Supersymmetry transformation in nine dimension

Now we go to nine dimension by compactifying three dimensions as before with the metric (3.2). Eventually we decompactify some of dimensions to obtain ten-dimensional supergravity. As in the bosonic case, we have two different but equivalent presentation of supergravities in nine dimension, which decompactify in ten dimension to IIA or IIB supergravity.

We consider ten-dimensional Poincaré symmetry including the y' -direction to have IIB supergravity. We now choose a supersymmetry generating spinor as Weyl

$$\mathcal{E} = \begin{pmatrix} \epsilon_1 \\ 0 \\ 0 \\ -i\epsilon_2 \end{pmatrix}, \quad (4.16)$$

where each ϵ_1, ϵ_2 has 16 real components. Since each Γ^x, Γ^y , or $\Gamma^{y'}$ anticommutes the rest of the gamma matrices, we can push it to the rightmost to directly act on \mathcal{E} . In this explicit form, we can act any gamma matrices. In nine-dimension, all the components of the twelve-dimensional spinor form linear combinations. For example,

$$\mathcal{E} \rightarrow \epsilon_1 - i\epsilon_2 \equiv \varepsilon^*, \quad \Gamma^{y'} \mathcal{E} = \begin{pmatrix} 0 \\ -\epsilon_2 \\ i\epsilon_1 \\ 0 \end{pmatrix} \rightarrow i\epsilon_1 - \epsilon_2 = i\varepsilon, \quad (4.17)$$

where we have combined two real Majorana spinors into one complex in nine dimension. Similar relations are shown in (B.23) in the appendix. This shows how the twelve-dimensional structure selects the spinor, which cannot be seen in ten dimensions.

We have essentially the same form for the transformation of the antisymmetric tensor fields in ten dimensions. We investigate the transformations of the gravitinos

$$\begin{aligned} L^{-1/2} \delta \psi_\alpha &= \left(E_\alpha^\mu \nabla_\mu - \frac{L^{-1}}{4} \gamma_\alpha^\mu \partial_\mu L - \frac{iL^{3/2}}{24} (3\tilde{\mathbb{F}}_5^w \gamma_\alpha + \gamma_\alpha \tilde{\mathbb{F}}_5^w) \right) \varepsilon \\ &+ \left(-\frac{iL^{3/2}}{8} (\tilde{\mathbb{F}}_3^w \gamma_\alpha - \gamma_\alpha \tilde{\mathbb{F}}_3^w) + \frac{L^{3/2} \tau_2}{8} (\mathbf{h}_2 \gamma_\alpha - \gamma_\alpha \mathbf{h}_2) \right) \varepsilon \end{aligned} \quad (4.18)$$

$$+ \frac{1}{24} (3\tilde{\mathbb{H}}_3 \gamma_\alpha - \gamma_\alpha \tilde{\mathbb{H}}_3) + \frac{1}{24L^{3/2} \tau_2} (3\mathbb{H}_2 \gamma_\alpha - \gamma_\alpha \mathbb{H}_2) - \frac{i}{24\tau_2} (3\tilde{\mathbb{F}}_3 \gamma_\alpha + \gamma_\alpha \tilde{\mathbb{F}}_3) \varepsilon^*.$$

$$L^{-1/2} \delta \psi_x = \left(-\frac{L^{-1}}{2} \gamma^\mu \partial_\mu L - \frac{iL^{3/2}}{12} \tilde{\mathbb{F}}_5^w \right) \varepsilon + \left(\frac{1}{6} \tilde{\mathbb{H}}_3 + \frac{i}{6L^{3/2} \tau_2} \mathbb{H}_2 - \frac{i}{12\tau_2} \tilde{\mathbb{F}}_3 \right) \varepsilon^*. \quad (4.19)$$

$$L^{-1/2} \delta \psi_y = - \left(\frac{L^{-1}}{2} \gamma^\mu \partial_\mu L + \frac{1}{4} \mathbb{F}_1 + \frac{iL^{3/2}}{12} \tilde{\mathbb{F}}_5^w \right) i\varepsilon + \left(-\frac{1}{12} \tilde{\mathbb{H}}_3 + \frac{1}{6L^{3/2} \tau_2} \mathbb{H}_2 + \frac{i}{6\tau_2} \tilde{\mathbb{F}}_3 \right) i\varepsilon^*. \quad (4.20)$$

Here the decomposition becomes straightforward in the local flat coordinates. Also $\gamma_\alpha^\mu = \frac{1}{2} [\gamma_\alpha, \gamma^\mu]$. In this section, Greek indices are nine-dimensional.

Using the result of subsection 3.2, summarized in (B.7)–(B.9) in the appendix, we reduce the five-form field strength in (4.14) as

$$\frac{1}{4!}\mathcal{G}_{abcdy'}\Gamma^{abcd} = L^2\tilde{\mathbb{F}}_5^w\Gamma^{y'} + L^{1/2}\tilde{\mathbb{H}}_3\Gamma^x + L^{1/2}\tau_2^{-1}\tilde{\mathbb{F}}_3\Gamma^y + L^{-1}\tau_2^{-1}\mathbb{H}_2\Gamma^x\Gamma^y \quad (4.21)$$

where we used $(\Gamma^A)^2 = 1$ for $A = x, y, y'$. Note that we have a chirality flipping operator Γ^y from the ten-dimensional point of view. We have straightforward definitions

$$\tilde{\mathbb{F}}_5^w \equiv \frac{1}{5!}\tilde{F}_{\alpha\beta\gamma\delta y'}\gamma^{\alpha\beta\gamma\delta y'} = \frac{1}{4!}\tilde{F}_{\alpha\beta\gamma\delta y'}\gamma^{\alpha\beta\gamma\delta}\gamma^{y'}, \quad (4.22)$$

$$\tilde{\mathbb{F}}_3 \equiv \frac{1}{3!}\tilde{F}_{\alpha\beta\gamma}\gamma^{\alpha\beta\gamma}, \quad (4.23)$$

and similar definitions are given in (B.16)–(B.22) in the appendix. Going down to nine-dimension, we need to keep only the 16×16 block of the gamma matrices, thus we then replace all Γ^α to γ^α and their antisymmetrized. Although each gamma matrix flips the chirality, we always have even number of gamma matrices, so that we have only one chirality thus far.

4.4 Emergent component of the gravitino

Although we did not have the y' -component of the gravitino in the original theory, this may arise as follows. First, we have redundant dimensional relation for $e_{\underline{y}'}^{y'}$ in (3.24). From its supersymmetry variation, we define an auxiliary gravitino component $\Psi_{\underline{y}'}$

$$\delta e_{\underline{y}'}^{y'} = -\frac{1}{L^3\tau_2^2}(\tau_2\delta e_{\underline{x}}^x + \delta e_{\underline{y}}^y) \equiv \frac{1}{2}\bar{\mathcal{E}}\Gamma^{y'}\Psi_{\underline{y}'}. \quad (4.24)$$

By the transformations of the other fields in (4.24) that we already know in (4.15), we have effectively defined a new component

$$\Psi_{\underline{y}'} = -\frac{1}{L^3\tau_2^2}(\Gamma^{y'})^{-1}(\tau_2\Gamma^x\Psi_{\underline{x}} + \Gamma^y\Psi_{\underline{y}}). \quad (4.25)$$

Going to local Lorentz coordinates, we get a simpler relation

$$\Psi_{\underline{y}'} = -\Gamma^{y'}(\Gamma^x\Psi_{\underline{x}} + \Gamma^y\Psi_{\underline{y}}), \quad (4.26)$$

using $(\Gamma^{y'})^{-1} = \Gamma^{y'}$. In fact, we do not have covariance along each direction, but this does not matter because all the directions involved here are compact. Rewriting the form making the y' dependence explicit, we have exactly the same transformation as the other coordinate, that is eq. (4.18) with the index α replaced by y' . Note that because of the even number of gamma matrices, we have the same chirality.

Here is where the supersymmetry comes into play. In the bosonic sector, ten-dimensional Lorentz invariance in IIB space including the y' -direction forced the degree of freedom $e_{\underline{y}'}^{y'}$ to not be independent as in (3.11). The supersymmetry related this field to $\Psi_{\underline{y}'}$. Therefore, we have the same bosonic degrees of freedom in twelve dimension as those of eleven-dimensional supergravity. All the fields in the twelfth direction are emergent, along with the graviton in (3.24). This circumvents the no-go theorem by Nahm [25].

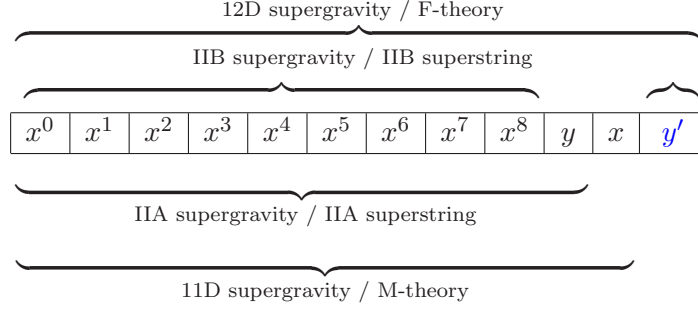


Figure 3. Configuration of twelve-dimensional geometry and our convention of coordinate notations. The IIA supergravity lives in ten dimension having coordinates (x^0, \dots, x^8, y) , whereas another combination (x^0, \dots, x^8, y') are spanned by the IIB supergravity, each of which has *different* ten-dimensional Poincaré symmetry. Only the time direction has the opposite Lorentz signature.

4.5 The IIB supergravity transformations

We go to ten dimension by decompactifying the y' -direction, whose configuration is shown in figure 3. To obtain the conventional form, we modify the definition on gravitinos and dilatinos and perform dimensional reduction again

$$\psi_\alpha^{\text{new}} \leftarrow L^{-1/4} \left(\Psi_\alpha + \frac{1}{2} \Gamma_\alpha \Gamma^y \Psi_y \right), \quad \lambda^{\text{new}} \leftarrow L^{-1/4} (\Gamma^x \Psi_x - \Gamma^y \Psi_y), \quad \varepsilon^{\text{new}} \leftarrow L^{-1/4} \varepsilon \quad (4.27)$$

The application of Γ^y puts an extra i in Ψ_y . We will drop the superscript ^{new} in what follows without confusion. The dilatino λ is the superpartner of the dilaton τ_2 and this redefinition extracts the component.

Going to general coordinates, we have

$$\begin{aligned} \delta\lambda &= -\frac{1}{2} \gamma^\mu (L^{-1} \partial_\mu L + i \partial_\mu A) \varepsilon \\ &+ \frac{1}{4} \left(\frac{i}{\tau_2} \tilde{\mathbb{F}}_3^{\text{wo}} + i L^{3/2} \mathbb{F}_3^{\text{w}} - \tilde{\mathbb{H}}_3 - L^{3/2} \tau_2 \mathbf{h}_2 \right) \varepsilon^*, \\ \delta\psi_\mu &= \left(\nabla_\mu - \frac{L^{-1}}{4} \gamma_\mu \gamma^\nu \partial_\nu L + \frac{i}{8} \gamma_\mu \mathbb{F}_1 + \frac{i L^{3/2}}{8} \tilde{\mathbb{F}}_5^{\text{w}} \gamma_\mu + \frac{1}{4 L^{3/2} \tau_2} (\mathbb{H}_2 \gamma_\alpha - \gamma_\alpha \mathbb{H}_2) \right) \varepsilon \\ &+ \frac{1}{8} \left(\gamma_\mu \tilde{\mathbb{H}}_3 - \tilde{\mathbb{H}}_3 \gamma_\mu - L^{3/2} \tau_2 (\mathbf{h}_2 \gamma_\mu - \gamma_\mu \mathbf{h}_2) - \frac{i}{\tau_2} \tilde{\mathbb{F}}_3^{\text{wo}} \gamma_\mu - i L^{3/2} \mathbb{F}_3^{\text{w}} \gamma_\mu \right) \varepsilon^*, \end{aligned} \quad (4.28) \quad (4.29)$$

and essentially the same term in the y' direction as the last (4.29). Using the results of the previous section, we obtain ten-dimensional fields out of the nine-dimensional ones

$$L^{3/2} \tilde{\mathbb{F}}_5^{\text{w}} = \frac{1}{\tau_2} \tilde{\mathbf{F}}_5^{\text{w}(10)} \equiv \frac{1}{5!} \tilde{F}_{\mu\nu\rho\sigma y'}^{(10)} \gamma^{\mu\nu\rho\sigma y'}, \quad (4.30)$$

$$\tilde{\mathbb{H}}_3 + L^{3/2} \tau_2 \mathbf{h}_2 \gamma^{y'} = \tilde{\mathbf{H}}_3^{(10)} \equiv \frac{1}{3!} \tilde{H}_{\mu\nu\rho}^{(10)} \gamma^{\mu\nu\rho}, \quad (4.31)$$

$$\frac{1}{\tau_2} \tilde{\mathbb{F}}_3^{\text{wo}} + L^{3/2} \mathbb{F}_3^{\text{w}} = \frac{1}{\tau_2} \tilde{\mathbf{F}}_3^{(10)} \equiv \frac{1}{3!} \tilde{F}_{\mu\nu\rho}^{(10)} \gamma^{\mu\nu\rho}. \quad (4.32)$$

noting that $r = L^{-3/2}\tau_2^{-1}$. Note again in (4.31), $\mathbf{h}_2 = \partial_\mu b_\nu \Gamma^{\mu\nu}$ came from KK graviton from eleven-dimensional supergravity point of view, not from \mathcal{C}_4 . But it becomes the component of ten-dimensional Kalb-Ramond field of IIB supergravity in the decompactification limit, as seen in (3.11). Also note that $\tilde{\mathbb{H}}_3$ can be rewritten as

$$\tilde{\mathbb{H}}_3 \equiv \frac{1}{3!} (H_{\alpha\beta\gamma} + 3K_{[\alpha} h_{\beta\gamma]}) \gamma^{\alpha\beta\gamma},$$

using the relation (3.10). Also, we have decompactification of gravitons

$$E_\alpha^\mu \nabla_\mu \varepsilon = \left(E_\alpha^\mu \nabla_\mu + \frac{1}{4L^{3/2}\tau_2} (\mathbb{H}_2 \gamma_\alpha - \gamma_\alpha \mathbb{H}_2) \right) \varepsilon.$$

Now we consider self-duality of four form field. We have Hodge-like duality for gamma matrices in twelve dimensions,

$$\Gamma^{M_1 \dots M_5} \Gamma = \frac{1}{7!} \epsilon^{M_1 \dots M_{12}} \Gamma_{M_6 \dots M_{12}}. \quad (4.33)$$

Fixing one index on the left-hand side to be y' and two of the indices to be x and y on r.h.s. also gives ten-dimensional relation

$$\gamma^{\mu_1 \dots \mu_4 y'} \gamma^{10} = \frac{1}{5!} \epsilon^{\mu_1 \dots \mu_{10}} \gamma_{\mu_6 \dots \mu_{10}}, \quad (4.34)$$

where γ -matrices are ten-dimensional but the indices do not take y' . This means,

$$\begin{aligned} \tilde{\mathbf{F}}_5^{\text{w}} &= \frac{1}{5!} \tilde{F}_{\mu_1 \dots \mu_4 y'} \gamma^{\mu_1 \dots \mu_4 y'} \gamma^{10} \\ &= \frac{1}{(5!)^2} \tilde{F}_{\mu_1 \dots \mu_4 y'} \epsilon^{\mu_1 \dots \mu_4 y' \mu_6 \dots \mu_{10}} \gamma_{\mu_6 \dots \mu_{10}} \\ &= \frac{1}{5!} \tilde{F}^{\mu_6 \dots \mu_{10}} \gamma_{\mu_6 \dots \mu_{10}} \\ &= \tilde{\mathbf{F}}_5^{\text{wo}}. \end{aligned} \quad (4.35)$$

Therefore we again recover covariant form

$$\tilde{\mathbf{F}}_5^{\text{w}} = \frac{1}{2} \tilde{\mathbf{F}}_5^{\text{w}} + \frac{1}{2} \tilde{\mathbf{F}}_5^{\text{w}} = \frac{1}{2} (\tilde{\mathbf{F}}_5^{\text{w}} + \tilde{\mathbf{F}}_5^{\text{wo}}) = \frac{1}{2} \tilde{\mathbf{F}}_5, \quad (4.36)$$

with the indices of the last term now running over the full ten-dimensional coordinates including y' and the overall factor $\frac{1}{2}$.

Finally, we decompose ten-dimensional gamma matrices into nine-dimensional ones. From the charge conjugation property of twelve-dimensional spinors, introduced in the appendix,

$$\Gamma^{y'} \Psi_{\text{Maj}} = \Gamma \Psi_{\text{Maj}}, \quad \Gamma^{y'} \Psi_{\text{L}} = \Gamma \Psi_{\text{R}}, \quad \Gamma^{y'} \Psi_{\text{R}} = \Gamma \Psi_{\text{L}}.$$

We see that the consistent structure for the ten-dimensional γ -matrices reproducing these twelve-dimensional ones is

$$\gamma^{y'} \equiv \gamma^y = i \begin{pmatrix} 0 & -\mathbf{1} \\ \mathbf{1} & 0 \end{pmatrix}, \quad (4.37)$$

as in (4.9). Therefore the only possible choice for the remaining matrices is [4]

$$\gamma^\alpha = \gamma^\alpha \sigma^1, \quad \alpha = 0, 1, 2, \dots, 8, \quad \gamma^9 = \gamma^{y'}, \quad (4.38)$$

with the tensor product on the r.h.s. to make the l.h.s. ten dimensional understood, and $\sigma^1 = \begin{pmatrix} 0 & 1 \\ 1 & 0 \end{pmatrix}$. Thus we have transformations of IIB supergravity to the leading order [51, 52]

$$\delta \begin{pmatrix} 0 \\ \lambda \end{pmatrix} = -\frac{i}{2\tau_2} \gamma^\mu \partial_\mu \tau \sigma^1 \begin{pmatrix} \varepsilon \\ 0 \end{pmatrix} + \frac{i}{4\tau_2} \left(\tilde{\mathbf{F}}_3 + i\tau_2 \mathbf{H}_3 \right) \sigma^1 \begin{pmatrix} \varepsilon^* \\ 0 \end{pmatrix}, \quad (4.39)$$

$$\delta \begin{pmatrix} \psi_\mu \\ 0 \end{pmatrix} = \left(\nabla_\mu + \frac{i}{8\tau_2} \mathbf{F}_1 \gamma_\mu + \frac{i}{16\tau_2} \tilde{\mathbf{F}}_5 \gamma_\mu \right) \begin{pmatrix} \varepsilon \\ 0 \end{pmatrix} + \frac{1}{8} \left(\gamma_\mu \mathbf{H}_3 - \mathbf{H}_3 \gamma_\mu - \frac{i}{\tau_2} \tilde{\mathbf{F}}_3 \Gamma_\mu \right) \begin{pmatrix} \varepsilon^* \\ 0 \end{pmatrix}. \quad (4.40)$$

Here the complex structure τ of the torus defined in (3.1) reappears as axion-dilaton $\tau = A + ie^{-\phi}$ with the IIB dilaton $e^{-\phi}$.

Observe that the dilatino should have the opposite chirality to the supersymmetry generator, by σ^1 dependence from the ten-dimensional embedding of the gamma matrix (4.38). On the other hand, gravitinos have the same chirality, because we have always even number of gamma matrices resulting from even multiple of σ^1 . The chirality is hidden in the gamma matrix structure, since each gamma matrix flips the ten-dimensional chirality.

Summarizing, without expecting any low-energy theory, the choice (4.16) gave a particular presentation of nine-dimensional supergravity in the above form. Decompactification in the y' direction gave rise to a chiral theory of IIB supergravity in ten dimension.

This is counterintuitive to the known fact that compactification of a chiral theory on a torus gives rise to parity symmetric theory. For instance compactification of four-dimensional $\mathcal{N} = 1$ chiral theory on a torus gives rise to two dimensional (2, 2) theory. As argued [49], nine-dimensional supergravity is chiral, with massive modes which is absent in this four dimensional analogy. The massive fields are provided by KK modes along y' -direction (2.15). In the M-theory limit, this is understood as wrapped modes of M2-branes. In terms of type IIB language this is winding mode in the dual IIA string. The little algebra for ten-dimensional chiral massless fields is the same as that of nine-dimensional massive fields.

5 Reduction to IIA supergravity

Our main focus in this paper lies on IIB supergravity, for which the notations are prepared. Since the twelfth dimension concretely realizes the T -duality as compactification, it would be useful to compare the geometry and field contents of the IIA and IIB theory.

5.1 Field reduction

We go back to the nine-dimensional theory and consider the decompactification of the y direction, which is to be understood as type IIA supergravity. Indeed, it is understood as compactification of eleven-dimensional supergravity on the circle along the x -direction,

which is again understood as twelve-dimensional supergravity compactified on the circle along the y' -direction

$$ds^2 = L^{-1}G_{\mu\nu}dx^\mu dx^\nu + L^2(dx + A_\mu dx^\mu)^2 + r^2 dy'^2, \quad \mu, \nu = 0, 1, \dots, 9, \quad (5.1)$$

where we call this coordinate x , gives IIA supergravity. Here the ten dimensional vector $A_\mu = \{a_\mu, \tau_1\}$ has τ_1 as a component in the y -direction, as shown in table 1. We define

$$G_{\mu\nu\rho\sigma} = r^{-1}\mathcal{G}_{\mu\nu\rho\sigma y'} \equiv F_{\mu\nu\rho\sigma}, \quad G_{\mu\nu\rho x} = r^{-1}\mathcal{G}_{\mu\nu\rho x y'} \equiv -H_{\mu\nu\rho}.$$

Then

$$\begin{aligned} \mathcal{G}_{\alpha\beta\gamma\delta y'} &= E_\alpha^\mu E_\beta^\nu E_\gamma^\rho E_\delta^\sigma E_{y'}^{y'} \mathcal{G}_{\mu\nu\rho\sigma y'} + E_\alpha^\mu E_\beta^\nu E_\gamma^\rho E_\delta^x E_{y'}^{y'} \mathcal{G}_{\mu\nu\rho x y'} \\ &= E_\alpha^\mu E_\beta^\nu E_\gamma^\rho E_\delta^\sigma G_{\mu\nu\rho\sigma} + E_\alpha^\mu E_\beta^\nu E_\gamma^\rho E_\delta^x \mathcal{G}_{\mu\nu\rho x} \\ &= L^2(F_{\alpha\beta\gamma\delta} - 4H_{[\alpha\beta\gamma}A_{\delta]}), \end{aligned} \quad (5.2)$$

Since the zweifbein E has only diagonal component in the y' direction, we can always convert the antisymmetric tensor fields of twelve and eleven dimensions. Note that we are using the new metric. Further compactification on a circle in the y -direction, for which now we can use the metric (3.2), gives

$$\begin{aligned} \mathcal{G}_{\alpha\beta\gamma\delta y'} &= L^2(F_{\alpha\beta\gamma\delta} - 4a_{[\alpha}H_{\beta\gamma\delta]} + 4b_{[\alpha}F_{\beta\gamma\delta]y} + 12a_{[\alpha}b_{\beta}H_{\gamma\delta]y}), \\ \mathcal{G}_{\alpha\beta\gamma y y'} &= L^{1/2}\tau_2^{-1}(F_{[\alpha\beta\gamma]y} - a_y H_{\alpha\beta\gamma} + 3a_{[\alpha}H_{\beta\gamma]y} - 3a_y b_{[\alpha}H_{\beta\gamma]y}) \end{aligned}$$

This agrees well with the computations (B.7) and (B.9) in the appendix, with a little change of notations. The fields having an index on y follows the rule (3.16)

$$L^{1/2}\tau_2^{-1}F_{\alpha\beta\gamma y} = R_y L^{1/2}\tau_2^{-1}F_{\alpha\beta\gamma y}^{(10)} = L^2 F_{\alpha\beta\gamma y}^{(10)}.$$

All of these reproduce the rules of the dimensional reduction of eleven-dimensional supergravity to type IIA supergravity.

In the fermionic sector, we follow the conventional route. First take the Majorana generator (4.11) and take the first two entries which are eleven- and ten-dimensional Majorana spinor. Now the ten-dimensional gravitino have a combination from Ψ_x , so that

$$\psi_\alpha^{\text{new}} \leftarrow L^{-1/4} \left(\Psi_\alpha + \frac{1}{2}\Gamma_\alpha \Gamma^x \Psi_x \right), \quad \lambda^{\text{new}} \leftarrow L^{-1/4} \Psi_x, \quad \begin{pmatrix} \epsilon_1 \\ \epsilon_2 \end{pmatrix}^{\text{new}} \leftarrow L^{-1/4} \begin{pmatrix} \epsilon_1 \\ \epsilon_2 \end{pmatrix} \quad (5.3)$$

The dilatino is simply defined as the component Ψ_x without an extra gamma factor. Therefore there is no chirality flip.

5.2 Generalized T -duality and decompactification limits

We summarize the relations among supergravity theories, controlled by the shape and the size of the torus. From the requirement of ten-dimensional Lorentz invariance of type IIB

supergravity, we obtained the relation (3.23) among the radii of the circles in the x, y, y' directions. The final metric after the rescaling (3.33) is

$$ds^2 = L^2(dx + \tau_1 dy + (a_\mu - \tau_1 b_\mu) dx^\mu)^2 + L^2 \tau_2^2 (dy - b_\mu dx^\mu)^2 + L^{-4} \tau_2^{-2} dy'^2 + L^{-1} g_{\mu\nu} dx^\mu dx^\nu. \tag{5.4}$$

We have considered the following limits.

- Ten-dimensional IIA supergravity: $L \rightarrow 0, L\tau_2 \rightarrow \infty$. The complex structure τ_2 should grow faster than L^{-1} , which condition is achieved by $L \rightarrow 0, r \rightarrow 0$. We have ten-dimensional metric

$$ds_{\text{IIA}}^2 = L^3 \tau_2^2 dy^2 + g_{\mu\nu} dx^\mu dx^\nu.$$

We identify IIA dilaton and string coupling as $g_{\text{IIA}} = L^{3/2}$.

- Eleven-dimensional supergravity: $L \rightarrow \infty$. With finite τ_2 , the torus decompactifies and we have $r \rightarrow 0$. Using the identification of IIA coupling, the radius of the x -circle is $L\ell = g_{\text{IIA}}^{2/3} \ell = g_{\text{IIA}} \ell_s$ and the decompactification to eleven-dimensional supergravity is done in the strong coupling limit $g_{\text{IIA}} \rightarrow \infty$.
- Ten-dimensional IIB supergravity: $L \rightarrow 0$. Keeping τ_2 finite sends $r \rightarrow \infty$ and shrinks the torus, whose area is $L^2 \ell^2 \tau_2$. The ten-dimensional metric is

$$ds_{\text{IIB}}^2 = \frac{1}{L^3 \tau_2^2} dy'^2 + g_{\mu\nu} dx^\mu dx^\nu.$$

Although the extra torus is shrunk, there is axion-dilaton field in the spectrum, so that we are left with the complex structure as a footprint. The Kähler modulus L is absent in this limit.

These limit shows the T -duality relation between IIA and IIB theories, exchanging the y - and y' - directions. We thus have obtained and identified the fields, using the IIA radius $L_A = L^{3/2} \tau_2$,

$$g_{\text{IIB}} = \frac{1}{L_A} g_{\text{IIA}} = \tau_2^{-1}, \quad A = \tau_1$$

Since we have obtained T -duality as different dimensional reduction, we have generalized T -duality also as exchange. The Kaluza-Klein momenta (2.16) along the y' -direction becomes

$$M_k^2 = \frac{k^2}{\ell^2 \langle r \rangle^2} = \frac{k^2 \langle L \rangle^4 \tau_2^2}{\ell^2}. \tag{5.5}$$

winding of M2-brane along the torus of the area $\langle L \rangle^2 \ell^2 \tau_2$.

6 Discussion

We constructed twelve-dimensional supergravity action, whose compactification yields eleven-dimensional and type IIB supergravity actions. We also obtained supersymmetry

transformations at linear order of fermions, which agree with the known rules of IIB supergravity. Of course, further compactifications shall yield type IIA and type I supergravity actions, too.

The key observation is that we always have at least one compact dimension. The ten dimensions in which eleven-dimensional and IIB supergravities respectively live are different, and they are distinguished by different compact directions, as shown in figure 3. First we demanded the twelfth dimension to be a compact circle and be orthogonal to the other directions. Although we have introduced the graviton component $e_{y'}^{y'} \equiv r(x^m, y')$ in the new direction, requiring the existence of ten-dimensional Lorentz symmetry of IIB space forces us to relate $e_{y'}^{y'}$ with the components of other directions, becoming redundant. Therefore we have the same degrees of freedom as those of eleven-dimensional supergravity. This is how we circumvent the no-go theorem by Nahm on the non-existence of the supergravity with twelve-dimensional Poincaré symmetry with signature (1, 11).

In showing this, compactification of some dimensions and decompactification of others are crucial. There is no direct way to obtain covariant IIB supergravity directly from twelve dimensions. This is because, the off-diagonal components of the graviton of IIB theory emerges from components of antisymmetric tensor fields in M-theory $E_{y'}^\mu = C_{\mu xy}$. This is well-known problem showing the the notion of dimension and fundamental degrees of freedom is subtle, but solves the problem of obtaining a chiral theory from dimensional reduction [49]. Note that the metric tensor itself is not a physical observable and in the low energy we cannot distinguish its interaction from the interaction of the antisymmetric tensor field, which is sourced by an M2-brane. One way to understand this situation is to start with three dimensions x, y, y' compact and to consider various decompactification limits. Each vacua giving IIA and IIB has different Poincaré symmetry are controlled by the the moduli of the torus L and τ . However decompactification is not always well-defined and should be dealt with care. We attribute the existence of the decompactification of the y' -direction and the existence of ten-dimensional Poincaré symmetry to an independent formulation of type IIB string theory.

The following summary gives us some insights on the meaning of the twelfth dimension.

The four-form field of IIB supergravity is naturally understood as dimensional reduction of twelve-dimensional four-form field. Its tensor structure is naturally obtained by lifting the three-form field C_3 of eleven-dimensional supergravity to twelve-dimensional \mathcal{C}_4 . It follows that the corresponding source of M2-brane is understood as a three-brane wrapped on the circle $S_{y'}$.

Half of the components of four-form field of IIB supergravity is *defined* by what is known as self-duality condition in this framework. This condition is imposed to the combination \tilde{F}_5 in our notation, not F_5 . It originates from Hodge duality in twelve-dimension, which imposes the correct index structure.

Spinorial representation in twelve-dimension shows us how the IIA non-chiral fermion is re-arranged to IIB chiral ones. It comes from a special property in $4n$ -dimension in which Majorana spinor is converted to Weyl. However we have just embedded the eleven-dimensional spinors in the twelve-dimension while keeping only the eleven-dimensional Lorentz symmetry.

We can concretely perform T -duality as dimensional reduction, as shown in figure 1, and its generalization can be done to the objects of eleven-dimensional supergravity. Although we have known what rules are necessary to convert between the fields of IIA and IIB supergravities, and could exchange them by hand, this compactification tells us how to perform T -duality to the Lagrangian. Relation between T -dual radii are consequence of the existence of independent Lorentz symmetry in different spacetime where each supergravity lives.

To actually perform T -duality from IIA to IIB, we need a tower of KK states. They are provided by compactification of the dynamical y' -direction to recover the IIB string theory in ten dimension. The wrapping modes of M2-brane is now captured as KK fields: the wrapping number becomes the KK momentum in the y' -direction. In other words, we have a way to deal with winding or wrapping of classical strings and membranes in the effective field theory, which may enable us to capture physics at the self-dual radius.

Although the twelve-dimensional theory has only a complex structure for the extra torus than ten dimensions in the IIB spacetime, we can make use of this information explicitly. For example, obtaining realistic string constructed model in four dimensions requires knowledge of the full eight extra dimensions in the context of F-theory.

In this way we can discover strings and membranes. After decompactification of the twelfth dimension, the ten-dimensional Poincaré symmetry become nontrivial. Imposing Lorentz covariance to four-form field gives us a nontrivial condition determining the size of the twelfth dimension. This should be, because T -duality relates the radii of dual circles. Also reproduction IIB supergravity by dimensional reduction of twelve-dimensional supergravity, without extra degrees of freedom sets the string frame, reveals the string length in terms of a fundamental length. With the relation of radii, we can discover a classical string solution with the tension.

We hope this effective action can take into account the bulk and gravity action and facilitates direct calculation of realistic four-dimensional action obtained from F-theory compactification.

A Spinors in twelve dimension

We consider twelve-dimensional spinor with Lorentz signature $(1, 11)$. The Dirac spinor, transforming under the Clifford algebra, has 32 complex components. The minimal spinor here has 32 real components. It can be either Majorana, satisfying the further condition

$$\Psi_{\text{Maj}} = B^* \Psi_{\text{Maj}}^* \tag{A.1}$$

with the charge conjugation matrix

$$B = \Gamma\Gamma^{y'} = i \begin{pmatrix} & -\mathbf{1} \\ & \mathbf{1} \\ -\mathbf{1} & \\ & \mathbf{1} \end{pmatrix}, \quad B^*B = 1, \quad (\text{A.2})$$

or Weyl, the eigenstate of chirality operator Γ

$$\Gamma\Psi_L = -\Psi_L, \quad \text{or } \Gamma\Psi_R = \Psi_R. \quad (\text{A.3})$$

Here the matrices $\Gamma^{y'}$ and Γ were introduced in (4.5) and (4.6). These spinors are all exchangeable, by a special property in $4n$ -dimension,

$$\Psi_{\text{Maj}} = \begin{pmatrix} \psi_1 \\ \psi_2 \\ i\psi_1^* \\ -i\psi_2^* \end{pmatrix} \iff \Psi_L = \begin{pmatrix} \psi_1 \\ 0 \\ 0 \\ -i\psi_2^* \end{pmatrix} \iff \Psi_R = \begin{pmatrix} 0 \\ \psi_2 \\ i\psi_1^* \\ 0 \end{pmatrix}.$$

We have the following relation

$$\Gamma^{y'}\Psi_{\text{Maj}} = \Gamma\Psi_{\text{Maj}}^*, \quad \Gamma^{y'}\Psi_L = \Gamma\Psi_R^*, \quad \Gamma^{y'}\Psi_R = \Gamma\Psi_L^*.$$

Weyl spinors of opposite chirality are complex conjugate

$$\Psi_{\text{Maj}} = \begin{pmatrix} \psi_1 \\ \psi_2 \\ 0 \\ 0 \end{pmatrix} + B^* \begin{pmatrix} \psi_1^* \\ \psi_2^* \\ 0 \\ 0 \end{pmatrix} = \Psi_L + B^*\Psi_L^* = \Psi_R + B^*\Psi_R^*. \quad (\text{A.4})$$

With Lorentz signature (1, 10) we may have minimal spinor with 32 real components, which is however not of our concern. It is a spacelike torus on which F-theory is compactified to yield type IIB string theory with varying axion-dilator with the Lorentz signature (1, 9).

B Formulae

Here we summarize the formulae appeared in the main text and supplement details of derivations. We start from nine dimension plus three compact dimensions. We use the metric in the string frame (5.4), which obtained from the metric (3.2) after the rescaling (3.33). The corresponding inverse-zwölfbein is

$$E_A^M = \begin{pmatrix} L^{1/2}E_\alpha^\mu & 0 & 0 & 0 \\ L^{1/2}b_\alpha & L^{-1}\tau_2^{-1} & 0 & 0 \\ -L^{1/2}a_\alpha & -\tau_1\tau_2^{-1}L^{-1} & L^{-1} & 0 \\ 0 & 0 & 0 & L^{3/2}\tau_2^2 \end{pmatrix}, \quad e_M^A = (E^{-1})_M^A, \quad G_{MN} = e_M^A e_N^B \eta_{AB}. \quad (\text{B.1})$$

We have tensors in components in local Lorentz frame as in (3.6)

$$\mathcal{G}_{abcdy'} = \mathcal{G}_{mnpqy'} E_a^m E_b^n E_c^p E_d^q E_{y'}^{y'} = G_{mnpq} E_a^m E_b^n E_c^p E_d^q$$

where we used the definition.

$$\mathcal{C}_{\alpha\beta\gamma y'} = L^{3/2}(A_{[\alpha\beta\gamma]y'} - 3a_{[\alpha}B_{\beta\gamma]} + 3b_{[\alpha}A_{\beta\gamma]} - 6a_{[\alpha}b_{\beta}K_{\gamma]}), \quad (\text{B.2})$$

$$\mathcal{C}_{\alpha\beta xy'} = B_{\alpha\beta} + 2b_{[\alpha}K_{\beta]}, \quad (\text{B.3})$$

$$\mathcal{C}_{\alpha\beta yy'} = \tau_2^{-1}(A_{\alpha\beta} - \tau_1 B_{\alpha\beta} + 2a_{[\alpha}K_{\beta]} - 2\tau_1 b_{[\alpha}K_{\beta]}), \quad (\text{B.4})$$

$$\mathcal{C}_{\alpha xy'} = L^{-3/2}\tau_2^{-1}K_{\alpha}, \quad (\text{B.5})$$

$$\mathcal{C}_{\alpha\beta\gamma\delta xy} = (r^2 L^2 \tau_2)^{-1} A_{\alpha\beta\gamma\delta}. \quad (\text{B.6})$$

Here we have reflected the y' metric component, but these can be regarded as eleven-dimensional tensors as well, by simply dropping y' index. And we have the corresponding field strengths

$$\begin{aligned} \mathcal{G}_{\alpha\beta\gamma\delta y'} &= L^2(F_{[\alpha\beta\gamma\delta]y'} - 4a_{[\alpha}H_{\beta\gamma\delta]} + 4b_{[\alpha}F_{\beta\gamma\delta]} + 12a_{[\alpha}b_{\beta}H_{\gamma\delta]}) \\ &= L^2(F_{[\alpha\beta\gamma\delta]y'} + 4A_{y'[\alpha}H_{\beta\gamma\delta]} - 4B_{y'[\alpha}F_{\beta\gamma\delta]} \\ &\quad + 12A_{y'[\alpha}K_{\beta}H_{\gamma\delta]y'} - 12B_{y'[\alpha}K_{\beta}F_{\gamma\delta]y'}) \quad (\text{B.7}) \\ &= L^{1/2}\tau_2^{-1}(F_{[\alpha\beta\gamma\delta]y'}^{(10)} + 2A_{y'[\alpha}^{(10)}H_{\beta\gamma\delta]}^{(10)} - 3A_{[\alpha\beta}^{(10)}H_{\gamma\delta]y'}^{(10)} - 2B_{y'[\alpha}^{(10)}F_{\beta\gamma\delta]}^{(10)} + 3B_{[\alpha\beta}^{(10)}F_{\gamma\delta]y'}^{(10)}) \\ &= L^{1/2}\tau_2^{-1}\left(F_5^{w(10)} - \frac{1}{2}A_2^{(10)} \wedge H_3^{(10)} + \frac{1}{2}B_2^{(10)} \wedge F_3^{(10)}\right)_{[\alpha\beta\gamma\delta y']} \end{aligned}$$

$$\begin{aligned} \mathcal{G}_{\alpha\beta\gamma xy'} &= L^{1/2}(H_{\alpha\beta\gamma} + 3b_{[\alpha}H_{\beta\gamma]}) \\ &= L^{1/2}(H_{\alpha\beta\gamma} + 3K_{[\alpha}H_{\beta\gamma]}) \quad (\text{B.8}) \\ &= L^{1/2}H_{\alpha\beta\gamma}^{(10)}, \end{aligned}$$

$$\begin{aligned} \mathcal{G}_{\alpha\beta\gamma yy'} &= L^{1/2}\tau_2^{-1}(F_{\alpha\beta\gamma} - \tau_1 H_{\alpha\beta\gamma} + 3a_{[\alpha}H_{\beta\gamma]} - 3\tau_1 b_{[\alpha}H_{\beta\gamma]}) \\ &= L^{1/2}\tau_2^{-1}(\tilde{F}_{\alpha\beta\gamma} + 3\tau_1 K_{[\alpha}\tilde{F}_{\beta\gamma]y'}) \quad (\text{B.9}) \\ &= L^{1/2}\tau_2^{-1}\tilde{F}_{\alpha\beta\gamma}^{(10)}, \end{aligned}$$

$$\mathcal{G}_{\alpha\beta xy y'} = (L\tau_2)^{-1}H_{\alpha\beta}, \quad (\text{B.10})$$

$$= (L\tau_2)^{-1}H_{\alpha\beta}^{(10)} \quad (\text{B.11})$$

Here $\tilde{F}_{\alpha\beta\gamma}^{(10)} = F_{\alpha\beta\gamma}^{(10)} - AH_{\alpha\beta\gamma}^{(10)}$. Also

$$(dC)_{\alpha\beta\gamma\delta\epsilon xy} = (r^2 L^2 \tau_2)^{-1} F_{\alpha\beta\gamma\delta\epsilon}. \quad (\text{B.12})$$

Since $F_{\alpha\beta\gamma\delta y'}$ itself does not have reduce into several pieces, there is no associated decompactification term with K_I . Also note that although in the terms involving K_I , y' appears twice but this is not contradictory to the total antisymmetric index structure. The

combination (B.7), where the y -component is missing, and (B.9) with the y -component, can also give the IIA field (5.2), after using the decompactification field b_μ .

The following ‘dual fields’ do not appear in the action.

$$C_{\alpha\beta\gamma\delta xy} = L^2 \tau_2 A_{\alpha\beta\gamma\delta} \quad (\text{B.13})$$

$$(dC)_{\alpha\beta\gamma\delta\epsilon xy} = L^2 \tau_2 F_{\alpha\beta\gamma\delta\epsilon}. \quad (\text{B.14})$$

The other components of C_6 come from the dual field (3.19)

$$C_3 \wedge G_4|_{xy} = L^2 \tau_2 (A_2 \wedge H_3 - B_2 \wedge F_3 - A_3 \wedge H_2 - B_1 \wedge F_4). \quad (\text{B.15})$$

where $|_{xy}$ means we have set two of the components to be x and y , but in $C_1 \wedge G_4$ we have no that restriction. Therefore $(dC_6 - \frac{1}{2}C_3 \wedge G_4)|_{xy}$ provides the rest of the tensor (3.18), without the y' component. This is in agreement with the self-duality condition for \tilde{F}_5 as well.

Some definitions

$$\mathbb{F}_1 \equiv \gamma^\alpha \partial_\alpha A \quad (\text{B.16})$$

$$\tilde{\mathbb{F}}_5^w \equiv \frac{1}{5!} \tilde{F}_{\alpha\beta\gamma\delta y'} \gamma^{\alpha\beta\gamma\delta y'} = \frac{1}{4!} \tilde{F}_{\alpha\beta\gamma\delta y'} \gamma^{\alpha\beta\gamma\delta} \gamma^{y'}, \quad (\text{B.17})$$

$$\tilde{\mathbb{F}}_3 \equiv \frac{1}{3!} \tilde{F}_{\alpha\beta\gamma} \gamma^{\alpha\beta\gamma}, \quad (\text{B.18})$$

$$\tilde{\mathbb{H}}_3 \equiv \frac{1}{3!} (H_{\alpha\beta\gamma} + 3b_{[\alpha} H_{\beta\gamma]}) \gamma^{\alpha\beta\gamma}, \quad (\text{B.19})$$

$$\mathbb{H}_2 \equiv \frac{1}{2} H_{\alpha\beta} \gamma^{\alpha\beta}. \quad (\text{B.20})$$

A two-form in IIA side can be viewed as three-form in IIB side

$$\frac{1}{2} \mathbf{h}_2 \equiv \partial_\alpha h_{\beta\gamma} \gamma^{\beta\gamma} \equiv \frac{1}{2} h_{\beta\gamma} \gamma^{\beta\gamma} (\gamma^{y'})^2 = \frac{1}{3!} h_{\beta\gamma y'} \gamma^{\beta\gamma y'} \Gamma^{y'} = \mathbb{H}_3^w \gamma^{y'}, \quad (\text{B.21})$$

$$\tilde{\mathbb{F}}_3^w \equiv \frac{1}{3!} (f_{\beta\gamma y'} - A h_{\beta\gamma y'}) \gamma^{\beta\gamma y'} = \frac{1}{2} (f_{\alpha\beta} - A h_{\alpha\beta}) \gamma^{\alpha\beta} \gamma^{y'}. \quad (\text{B.22})$$

All the gamma matrices here are nine-dimensional.

The eleven-dimensional supersymmetry generators embedded in twelve dimension are reduced in nine dimension as follows

$$\Gamma^x \mathcal{E} \rightarrow \varepsilon^*, \quad \Gamma^y \mathcal{E} \rightarrow -i\varepsilon^*, \quad \Gamma^x \Gamma^y \mathcal{E} \rightarrow -i\varepsilon^*, \quad \Gamma^x \Gamma^{y'} \mathcal{E} \rightarrow i\varepsilon, \quad \Gamma^y \Gamma^{y'} \mathcal{E} \rightarrow \varepsilon. \quad (\text{B.23})$$

Some useful relations:

$$ab \nabla^2 (ab)^{-1} = 2a^{-2} (\partial_\mu a)^2 + 2b^{-2} (\partial_\mu b)^2 - a^{-1} \nabla^2 a - b^{-1} \nabla b. \quad (\text{B.24})$$

In the main text we consider the case $a = L, b = L\tau_1$. We also have

$$F_{ab} \Gamma^b = \frac{1}{2} (\Gamma_a \mathbb{F}_2 - \mathbb{F}_2 \Gamma_a).$$
